Subject: Compassionate appointment of Smt. Rama W/o late Pasha R/o H.No.147, Lane No.02, New Plot, Jammu under SRO-43 of 1994.

Ref:- F.No.LD(PAB)2019/13-Assembly dated 21-01-2021 from the Department of Law, Justice and Parliamentary Affairs.

ORDER

Sanction is hereby accorded to the temporary appointment of Smt. Rama W/o late Pasha (Ex-Table Boy) R/o H.No.147, Lane No.02, New Plot, Jammu, as Jewer, in the pay Level SL 1 (14800-47100) against the available vacancy on the establishment of Legislator's Hostel, Jammu, in relaxation of the prescribed qualification bar in terms of Rule-7 of SRO-43 of 1994.

The appointee shall report to Secretary, J&K Legislative Assembly within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of the following documents/certificates (in original) to be verified subsequently:-

- (i) Academic Qualification Certificate.
- (ii) Date of Birth Certificate.
- (iii) Domicile Certificate.
- (iv) Health Certificate from the concerned Chief Medical Officer of the District.
- (v) Dependent Certificate issued by the Assistant Commissioner, Revenue.
- (vi) No loan certificate under Self Employment Scheme from DIC concerned and Employment Department.
- (vii) All other relevant documents as are required under SRO-43/1994.

The appointment of the appointee shall further be subject to the following conditions:-


- (a) That she shall give an undertaking in the shape of an Affidavit to the effect that:-
 - (i) In case adverse report about her Character and Antecedents is received from the Inspector General of Police, (CID), J&K, to whom a reference shall be made by this Secretariat, she shall have no right to claim her appointment as Jewer in Legislators' Hostel, Jammu and her appointment, as such, shall be deemed to have been cancelled ab-initio;
 - (ii) If, on verification, genuineness of the qualification certificates from the concerned issuing authority is found fake/forged, the claim of



the appointee for appointment as Jewer shall also be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against her.

- (b) The salary of the appointee shall not be drawn and disbursed to her unless a satisfactory report in respect of (i) and (ii) above are received in her favour.
- (c) The appointee shall be initially on probation for a period of two years.
- (d) The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009.
- (e) If the appointee fails to join within the period of 21 (twenty one) days from the date of issuance of this order, she shall forego her right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.
