LEGISLATORS' HOME

ACCOMMODATION:

Accommodation facility is provided to all the Members of Karnataka Legislative Assembly at Building No. 2, 3, 4 & 5 of Legislators' Home which is coming under the jurisdiction of Karnataka Legislative Assembly Secretariat. Building-I is in the possession of Karnataka Legislative Council Secretariat for providing accommodation facility to the Members of Karnataka Legislative Council.

All these Buildings are situated in North Western direction of Vidhana Soudha, Jawaharlal Nehru Planetarium in East direction and Basaveshwara Circle in West direction.

The accommodation facilities has been provided to the Members of Karnataka Legislative Assembly in the following buildings, the details of which are as follows:-

The Rooms are fully furnished to equip the needs of the Hon'ble Members with adequate space. The Rooms are charged @ Rs. 500/- Per Month for single Room, Rs. 1,000/- per month for double/ Family Flat Room.

Guest Rooms are reserved subject to availability on requisition submitted in advance by the Sister Committee/Ex-MLAs of other states who visits the State. The Rooms will be reserved on the payment basis at the Rate of Rs. 100/- per day (for Three days only), Rs. 200/- per day thereafter up to Seven days. For any reason, the Rooms will not be provided for long duration.

On the request received from the Hon'ble Members, Guest Rooms are reserved in the name of their guest subject to availability. The rooms will be reserved on payment basis at the rate of Rs. 500/- per day for a single room (for Three days only) and Rs. 1,000/- per day after Three days and up to Seven days (period of stay has been confined only for Seven days)

Similarly Ex-members are also entitled to avail the accommodation. On the request received from the Hon'ble Ex-members guest rooms are reserved subject to availability. The rooms will be reserved on payment basis at the rate of Rs. 100/- per day for a single room(for three days only) and Rs. 200/- per day after three days and upto seven days. Rs. 400/- per day after seven days till vacating the room.

CONVEYANCE FACILITIES:

Vehicle facility has been provided by this Secretariat for the convenience of the Hon'ble Members.

The cars will be under the administrative control of The Secretary, Karnataka Legislative Assembly Secretariat.

The charges will be levied for both onward and backward journey. Where any car is requisitioned and made available to any Member, the hire charges will be levied from the time, the car is sent from the Legislators' Home till it is returned to Legislators' Home, whether the car is actually utilized or not.

The Vehicles will be arranged at free of cost to the Sister Committees of other States to Pick-Up and Drop from Airport / Railway Station / Bus Station and also to the meeting place.

EMERGENCY CAR:

There are emergency cars available for the use of Members for emergent/emergency purposes between 10.00 p.m. to 08.00 a.m. The hire charges for the emergency cars are levied for both forward and backward journey at regular rates but, waiting charges of Rs. 100/- is levied for every one hour after the first hour.

TELEPHONE FACILITIES:

Bills for the telephones installed in rooms at Legislators' Home are to be paid by the Members directly to BSNL.

BANKING FACILITIES:

Branches of the Karnataka State Co-operative Apex Bank and State Bank of India have been opened in Vidhana Soudha. A Branch of the Karnataka State Co-operative Apex Bank is also opened at Legislators' Home. State Bank of India has provided ATM Counters both at Vidhana Soudha and Legislators, Home.

POSTAL FACILITIES:

A post Office each is set up in Mezzanine Floor of Legislators' Home-2 and Room No.1, Ground Floor on the eastern side of Vidhana Soudha for the use of Members of Legislature.

CANTEEN FACILITIES:

Vegetarian and North Karnataka type of foods are available at Legislators' Home premises. Light refreshments are available to Members in the Legislative Assembly/Legislative Council lobbies during Sessions, on payment basis.

RESERVATION FACILITIES:

South Western Railway's and K.S.R.T.C.'s Bus Computerised Reservation counters are setup at Legislators' Home for the convenience of Members.

LAUNDARY FACILITIES:

There are two laundries attached to the Legislators' Home. The Members staying in Legislators' Home can make use of Laundry services on payment basis.

HEALTH CLUB FACILITIES:

A sophisticated "Health Club" equipped with latest gymnasium equipments under the care of experienced physical instructors is made available for the exclusive use of Members. It is situated near the Reception Counter in the Ground Floor, at the Legislators' Home premises.

MEETING HALL:

A Conference Hall with a seating capacity of around 150 seats is available at Legislators' Home Building-2. The Hall will be reserved for convening the meeting of Legislature Committees. Further, the Legislators' and Ex-MLAs may also avail Conference Hall for conducting meetings/functions and other non-political programs on payment basis subject to the terms and conditions. The said Hall will be charged Rs. 500/- for the period of first Three Hours and Rs. 1,000/- for the later period.

The House Committee Room is situated at Legislators' Home, Building No.4, which is kept exclusely for conducting House Committee Meetings.

There is a House Committee to consider and advice upon all matters connected with convenience and comforts of the Hon'ble Members of Legislative Assembly. The committee on House will be presided over by the Hon'ble Deputy Speaker of Legislative Assembly, which consists of 12 Members elected according to the principle of proportional representation by means of single transferable vote.

A Police Out-Post is situated in the premises of Legislators' Home for the purpose of providing safety and security to the Hon'ble Members & buildings of Legislators' Home. C.C. T.V. Cameras have been installed to keep surveillance about the movements of public across Legislators' Home.

The Legislators' Home Building 2, 3, 4 & 5 of Karnataka Legislative Assembly Secretariat is managed by the Estate Office and he is assisted by Two Assistant Estate Officers alongwith the other Staff. The Office of the Estate Officer

and Assistant Estate Officers is situated in Mezzanine Floor of Building No-2. The Reception Counters situated at Building 2, 3, 4 & 5 helps to facilitate the Hon'ble Members to avail Rooms, conveyance and other related facilities.
