### AUTUMN SESSION, FRIDAY, 22<sup>ND</sup> SEPTEMBER, 2023

The House met at 10.00 a.m. and sat till 1.25 P.m.

The day was allotted for Government Business.

#### 1. QUESTIONS:

Question Nos. 174, 175, 176, 177 were taken up and disposed off.

#### 2. ZERO HOUR:

Shri Adelbert Nongrum, MLA moved a Zero Hour notice under Rule 49 of the Rules of Procedure and Conduct of Business to the news item published in "East Mojo" under the caption "Meghalaya's Cherry Blossom to be held in November". Shri Paul Lyngdoh, Minister Tourism replied.
