Minutes of the virtual meeting held under the chairmanship of Secretary, Ministry of Parliamentary Affairs, Government of India on Friday, 17th February, 2023 at 10:30 A.M with Odisha Legislative Assembly.

The virtual meeting to review the progress status of National e-Vidhan Application(NeVA) in Odisha Legislative Assembly was held under the Chairmanship of Secretary, Ministry of Parliamentary Affairs (MoPA), GOI on Friday the 17th February,2023 at 10.30 A.M. The list of Participants is Annexed.

At the outset, the Secretary welcomed all the participants and enquired about the current status of the NeVA project in their state. Principal Secretary, E&IT Department, Govt of Odisha along with the NIC representative briefed about the progress of NeVA implementation in their state.

After discussions and deliberations, the following decisions were taken:-

- 1. The Principal Secretary, E&IT Department, Govt of Odisha informed that NeVA Project for the Odisha Legislative Assembly has been approved and Odisha Assembly has adopted 10 Modules of NeVA and pre work of Hardware installation is done. Bills/Reporters/ E-book Modules will be adopted by 31<sup>st</sup> March. Inside the House installation of Hardware would be done after the Budget Session of the Assembly.
- 2. The Principal Secretary, E&IT Department highlighted issues regarding local customisation of NeVA software w.r.t. Odisha Assembly. He also raised issue of non availability of Ticket System for tracking Pending complaints in the software, Secretary MPA directed NIC, CPMU NeVA to develop Ticket System for tracking of redressal of complains for help of all the States. Secretary MPA enquired about Status of Training Programme in Odisha.
- 3. The OSD-cum-Secretary, Odisha Legislative Assembly informed requisite training Workshops on NeVA has been conducted for the Assembly and once hardware is installed inside the House further training programme will be conducted. Director (IT), NIC, NeVA was asked to prepare training program for Odisha Assembly.
- 4. The Secretary, MoPA asked NIC Odisha to brief Hon'ble Speaker of the Assembly about the NeVA Application for Digital Legislatures and stated that NIC/NICSI should review the progress status with regard to all the technical aspects and the procurement process on fortnightly basis and provide the Status report.
- 5. The Secretary, MoPA informed the participants about the proposed National Workshop at the end of February / early March, 2023 for all the states to undertake review of the status of NeVA, discussion of the issues being confronted in its implementation in all the States and sharing of experience of the States that have already digitalised their Houses through NeVA. He requested for participation of Assembly/ State Govt.
