- (c) The different rate/estimated cost of the housing units. Giving reasons for the enhancement of the price/rate at different levels.
- (d) How many SGAY housing units are proposed to be sanctioned in the proposed budget financial year 2023-24? What is the total cost and cost estimated per unit?
- (e) Please provide the details of any additional facilities to be provided in the SGAY housing units.
- (f) Please furnish the criteria cum guidelines for the selection of the beneficiaries w.r.t. SGAY.
