

## **Salaries and Allowances to the Member of the Legislative Assembly,**

### **1. SALARY:**

There shall be paid to each Member during the whole of his term of office a salary per month at the rate of minimum basic pay i.e. Rs.78800/-payable to a Deputy Secretary in the State Government.

### **2. DEARNESS ALLOWANCES:**

There shall be paid to each Member during the whole of his term of office per month, the dearness allowance on the amount of the basic salary at such rate as is being paid to the employees of the State Government from time to time.

### **3 OTHER ALLOWANCE.**

(A) COST OF TELEPHONE CHARGES Rs.7000/- P.M.

(B) POSTAL AND STATIONERY CHARGES Rs.5000/- P.M.

(C) PERSONAL ASSISTANT ALLOWANCE Rs.20000/- P.M.

### **4. DAILY ALLOWANCE:**

Rs. 1000/- per day

### **5. TRAVELLING ALLOWANCE:**

(a) **By Rail or steamer:** One and One half of first class fare.

(b) **By Road:** In a owned, hired or borrowed conveyance, the following rates are admissible.

Conveyance by which journey is performed	Rates of road mileage
(1) Motor Car (petrol driven)	Rs. 8-00 per k.m.
(2) Motor Car (diesel driven)	Rs. 7-00 per k.m
(3) Motor Car(C.N.G.)	Rs. 4-00 per k m
(3) Two wheelers (Motor cycle/scooter)	Rs. 2-00 per k.m.
(4) Any other means of conveyance	Rs. 2-00 per k.m.

### **6. TRAVEL FACILITIES :**

#### **(A) BY AIR :**

(1) A member may undertake or perform journey along with a family member by air from nearest air port from his residence to and fro in any part of India on three occasions in each year.

(2) The expenditure incurred by a member for such travel by air shall be reimbursed to him to the extent of an amount equal to the fare for journey by railway by first class or second class air conditioned, whichever is higher.

#### **(B) BY ROAD :**

A member is entitled to travel, on presentation of identity card free of charge singly or jointly with his spouse and two other members of his family residing with and dependent on him within the State of Gujarat by the service buses of Gujarat State Road Transport Corporation.

**(C) BY RAIL :**

(1) A member is entitled to travel by railway by first class or by second class air conditioned singly or jointly with his spouse and two other members of his family residing with and dependent on him in any part of the State of Gujarat.

(2) The member is also entitled to travel 10,000 kms. singly and 20,000 kms. jointly with above mentioned co-travelers, within a financial year in any part of India out side the State of Gujarat.

**7. TELEPHONE FACILITY:**

Where a member has a telephone installed at his residence, the rental charge in respect of such telephone is borned by Government. Telephone is also provided to each member at his residential quarter in MLA Hostel on which a member is entitled to make local calls free of charge.

**8. HOUSING FACILITIES :**

A member is provided with residential accommodation in MLA Hostel at the rent of Rs. 1.25 per day.

**9. MEDICAL FACILITIES :**

Members, Ex-members and their family members who are residing with them and dependent upon them are entitled to free medical facility in hospitals run by the State Government. They are also entitled to medical facility from the Hospitals run by Municipalities, Panchayats, Grand-in-aid institutions, G.M.E.R.S Government Medical Colleges as well as Private Medical Colleges Hospitals.

Moreover, sitting Members and their family members who are residing with and dependent upon them are also entitled to medical facility as indoor as well as outdoor patients in any Private hospitals within the State. The Ex-members and their family members who are residing with and dependent upon them are also entitled to medical facility in any Private Hospitals as indoor patients within the State as per package rate.

**10. Railway Reservation Counter Facilities :**

For the facility of the Members, Railway Reservation Counter in the Premises of the Assembly building is working.
