It is hereby enacted in the Seventy-fourth Year of the Republic of India as follows:-

1. (1) This Act may be called the Gujarat Natural Farming and
Organic Agricultural University (Amendment) Act, 2023.Short title and
commencement.

(2) It shall come into force on such date as the State Government may, by notification in the *Official Gazette*, appoint.

STATEMENT OF OBJECTS AND REASONS

The State Government has enacted the Gujarat Natural Farming and Organic Agricultural University Act, 2017 to establish and incorporate a University for the development of the natural farming and organic agricultural sciences in the State of Gujarat.

To promote natural farming in a scientific manner and to make available experienced and knowledgeable human resources in the field of natural farming and considering the basic difference between organic agriculture and natural farming, it is necessary to change the name of "the Gujarat Natural Farming and Organic Agricultural University" to "the Gujarat Natural Farming Science University". Accordingly, necessary amendments have been proposed in the said Act.

This Bill seeks to achieve the aforesaid object.


