4. OFFICIAL RESOLUTION.

- (1) **A MINISTER to move-** "that WHEREAS, Tomorrow marks the 555th Parkash Parv of the first Patshah, Shri Guru Nanak Dev Ji. On this occasion, this House Pays respectful homage to him. Through this resolution, it also extends heartfelt greetings to all in celebration of his Parkash Parv.
2. Earlier, in the year 2019, on the 550th Prakash Parv of Shri Guru Nanak Dev Ji, following his teachings of 'Ek Pita Ekas Ke Hum Barak', a joint session of the Haryana and Punjab Legislative Assemblies was held.
3. The Kartarpur Sahib Corridor was inaugurated by the Hon'ble Prime Minister Sh Narendra Modi on 9th November, 2019, This August House also remembers this initiative with reverence.
4. This House believes that the creation of this corridor is a direct result of the immense grace of Shri Guru Nanak Dev Ji. He travelled to 22 countries, spreading the profound message that religion transcends the artificial boundaries imposed by man on earth and in society.
5. Haryana is fortunate that in the early 16th century, Shri Guru Nanak Dev ji sanctified this land with the dust of his feet. During his various 'Udaasis', he visited Haryana and guided the people here on the true path of religion. In his first 'Udaasi' in 1508 AD, he travelled to Sirsa via Sultanpur, and then proceeded to Karah, Pehowa, Kurukshetra, and Kapalmochan, spreading his divine message along the way.

6. During his second Udaasi, Shri Guru Nanak Dev Ji visited Karnal and Panipat and in his third Udaasi, he visited Pinjore, Ambala and Shahabad. 'Guru ghar' of the first Patshahi are established at all these places, which have been spreading the light of the teachings of Shri Guru Nanak Dev Ji for centuries. These places have now become holy pilgrimages and throughout the year the devotees are visiting there and improving their lives.

7. The teachings of Shri Guru Nanak Dev Ji will always be remembered for spiritual enlightenment, worldly prosperity and social harmony. He taught humanity the lesson of 'Kirat Karo, Naam Japo and Wand Chhako' centuries ago.

8. Today I want to inform this August House that a 700-bedded government hospital is being constructed in Gurugram at a cost of about Rs 1000 crore. We have decided that this hospital will be named after Shri Guru Nank Dev Ji.

9. I would also like to inform the House that Gurdwara Shri Chilla Sahib in Sirsa holds great historical significance as first Guru Sahab Shri Guru Nanak Dev Ji blessed the place by staying there and observed Chilla for forty days. Guru ji's teachings have guided the entire world. In July this year, the government graciously transferred 77 Kanal 7 Marla of land, free of cost, as a gift to Gurdwara Shri Chilla Sahib, Sirsa, Further honouring this place of immense spiritual importance.

10. We have received a request from the Sikh community to establish a chair in the name of Guru Nanak Dev Ji at a university in Haryana. In response to this, we have decided to approve such a proposal in accordance with the policy of the Higher Education Department, dated January 18, 2024.

11. This August House believes that with the blessings of Shri Guru Sahiban, Haryana will continue to grow in glory and progress on the path of development. The principles of harmony, tolerance, brotherhood, and mutual love that they have shown us should be embraced in our lives. These values form the foundation of human welfare, and adopting them is the truest tribute we can offer to him.

12. I respectfully request this August House that a congratulatory resolution be passed to mark this Parkash Parv, a celebration filled with the devotion and reverence of the people of Haryana.
