Quality of Canal Water

***41 Ch. AFTAB AHMED (Nuh):**

Will the Chief Minister be pleased to state:-

a) whether it is a fact that the quality of water flowing in Gurugram canal is very poor; if so, the steps are being taken by the Government to solve the said problem togetherwith its present status thereof;

b) whether any testing of above said contaminated water has been conducted by the Government ; if so, the details of the report thereof; and

C) the complete details of the action taken against the guilty persons who are responsible for contamination of said Gurugram canal water?

To Construct By-Pass

***42 Sh. SANJAY SINGH (Sohna):**

Will the Deputy Chief Minister be pleased to state whether there is any proposal under consideration of the Government to construct Tauru by-pass which is to be constructed from Didhara road to Sohnna road via Pataudi road

in Tauru city of Sohna Assembly Constituency as per the announcement of the Hon'ble Chief Minister?

To Metal the Unmetalled Passages

b) if not, whether any plan has been made by the Government to solve the said problem in future togetherwith the details thereof?

The Details of Paper Leak Cases

Beautification and Maintenance of Ponds

To Open Mahila Sanskriti Centres

Shortage of Drinking Water Supply

b) if so, the time by which it is likely to be formulated; and

c) the details of arrangements made by the Government for drinking water facility in above said villages at present?

b) if so; the reasons thereof togetherwith the time by which the above said works are likely to be completed?
