- b) the reasons for the delay in completion of the abovesaid road together with the reasons of breaking of road even at the time of its construction?

To Regularize the Guest Teachers

Will the School Education Minister be pleased to state:-

- a) whether there is any proposal under consideration of the Government to regularize the services of Guest Teachers working in Government Schools in the State; and
- b) if so, the time by which the services of the abovesaid Guest Teachers are

To Prevent the Flood

xiii) Jundla to Jaini extension up to front of Staundi (Munak to Karnal road)

xiv) Ganga Teri to Kaul Khera;

c) if not, the reasons for which the work is not being started so far?
