THE HARYANA APPROPRIATION (No. 4) BILL, 2023

A

BILL

to provide for the authorization of appropriation of money Out of the Consolidated Fund of the State of Haryana to meet the amount spent on certain services during the financial years 2011-12, 2012-13, 2013-14, 2014-15, 2015-16, 2016-17, 2017-18 and 2018-19 in excess of the amount authorized or granted for these services during these years.

BE it enacted by the Legislature of the State of Haryana in the Seventy- fourth Year of the Republic of India as follows :—

1. This Act may be called the Haryana Appropriation (No.4) Act, 2023.

Short title.

2. From and out of the Consolidated Fund of the State of Haryana, the sums specified in column 6 of the Schedule appended to this Act, amounting in the aggregate to the sum of Two Hundred Sixty-Three Crore, Forty-Four Lakh, Sixty-Nine Thousand, Six Hundred rupees only (₹263,44,69,600/-), Four Hundred Twenty-Eight Crore, Ten Lakh, Twenty Thousand, Eight rupees only (₹428,10,20,008/-), Three Hundred Twenty-Nine Crore, Sixty-Seven Lakh, Fifty Thousand, Eight Hundred Ninety-Three rupees only (₹ 329,67,50,893/-), Four Hundred Six Crore, Thirty-Five Lakh, Fifty-Five Thousand, Three Hundred Sixty-Seven rupees only (₹406,35,55,367/-), One Thousand Four Hundred Fourteen Crore, Twenty-Three Lakh, Eighty-Three Thousand, Eight Hundred Seventeen rupees only (₹ 1414,23,83,817/-), Two Hundred Fifty-Six Crore, Ninety-Eight Lakh, Seven Thousand, Six Hundred Ninety rupees only (₹256,98,07,690/-), Five Hundred Forty Crore, Fifty-Nine Lakh, Sixty-Nine Thousand, Three Hundred Seventy-Three rupees only (₹540,59,69,373/-) and Forty-One Crore, Fifty-Three Lakh, Eighty-Four Thousand, Six Hundred Seventy-One rupees only (₹41,53,84,671/-) shall be deemed to have been authorized to be paid and applied to meet the amount spent for defraying the charges in respect of the services specified in column 2 of the said Schedule during the financial years 2011-12, 2012-13, 2013-14, 2014-15, 2015-16, 2016-17, 2017-18 and 2018-19 respectively, in excess of the amount authorized or granted for these services during these years.

Appropriation.

3. The sums deemed to have been authorized to be paid and applied from and out of the Consolidated Fund of the State of Haryana under this Act, shall be deemed to have been appropriated for the services and purposes expressed in the Schedule in relation to the financial years 2011-12, 2012-13, 2013-14, 2014-15, 2015-16, 2016-17, 2017-18 and 2018-19.
