Sir,

- a) The Provision of section 21 (XXVI) of the Haryana Panchayati Raj Act, 1994, casts upon Gram Panchayats, a duty to construct and maintain Cattle Sheds and Cattle Pounds. Accordingly, all the Deputy Commissioners including Deputy Commissioner, Sirsa have been directed to get the needful done by Gram Panchayats within the limits of the funds available at their disposal.
- b) No, Sir as per information provided by Animal Husbandary & Dairying Department there is no proposal under consideration to provide any additional financial support per animal per day to the Gaushalas/Nandishalas over and above the existing formula/ rates. Details of grant provided by Animal Husbandary & Dairying Department to Gaushalas of Dabwali constituency is placed at Annexure.

(क) हरियाणा पंचायती राज एक्ट, 1994 के अधिनियम की धारा 21 (XXVI), जोकि ग्राम पंचायतों पर लागू होती है, के अनुसार ग्राम पंचायत का दायित्व है कि वे पशु शेड और पशुबाड़ा का निर्माण और रखरखाव करेंगी। तदानुसार, सभी उपायुक्तों (उपायुक्त सिरसा सहित) को ग्राम पंचायतों के पास उपलब्ध संसाधनों/स्रोतों की सीमा के अन्तर्गत आवश्यक कार्यवाही करने के निर्देश दिए गए हैं।

(ख) नहीं, महोदय पशुपालन और डेयरी विभाग द्वारा उपलब्ध करवाई गई सूचना अनुसार गौशालाओं/नंदीशालाओं को प्रति दिन प्रति पशु के हिसाब से अतिरिक्त वित्तीय सहायता देने बारे कोई प्रस्ताव विचाराधीन नहीं है। पशुपालन एवं डेयरी विभाग द्वारा डबवाली विधानसभा क्षेत्र की गौशालाओं को दिए गए अनुदान का विवरण अनुबंध अनुसार साथ संलग्न है।
