14/15/469. Smt. GEETA BHUKKAL (Jhajjar):

Will the Deputy Chief Minister be pleased to state the latest position of the following roads of Jhajjar Constituency : -

- i) Matanhail to Salhawas Road via Akheri Madanpur and Ladain;
- ii) Internal roads of Jhajjar City; and
- iii) road from Dadri Chowk to Ramlila ground via Ambedkar Chowk?

- i) The condition of road from Matanhail to Salhawas via Akheri Madanpur and Ladain is motorable and being maintained through routine patch work. The Government of Haryana vide ACSPW Chandigarh memo no. 09/266/2022-3B&R(W) dated 16.01.2023 has accorded administrative approval for 64.00 Crore approximately for widening of Matanhail Salhawas Kosli road in Jhajjar District km 0.00 to km 19.00 in Jhajjar District under NCRPB Loan Assistance Scheme. The work shall be started after approval of Project Sanctioning and Monitoring Group-I (PSMG-I), NCRPB, New Delhi.
- ii) The condition of internal roads of Jhajjar city are motorable. All roads of Jhajjar city are being maintained through routine patch work.
- iii) The condition of road from Dadri Chowk to Ramlila ground via Ambedkar Chowk is motorable and being maintained through routine patch work. Administrative Approval for this road improvement amounting to Rs. 867.71 Lacs has been granted by Govt. vide memo no. 09/89/2023-3B&R(W) dated 17.02.2023 (under MLA priority list).

NOTE FOR PAD

- 1) The total length of Matanhail to Salhawas via Akheri Madanpur and ladin road is 19.00 Km. The carriageway width of this road is 7.00 meter. The condition of the road from Matanhail to Salhawas is in motorable condition and presently it is being maintained through the routine patch work by the department. The road from RD 0.00 to 18.040 Km falls under Jhajjar constituency. The road from RD 0.00 to 18.040 was last treated in the year 2015 with provision of 60mm DBM+40mm BC. This road is not under DLP. The Government of Haryana vide ACSPW Chandigarh memo no. 09/266/2022-3B&R(W) dated 16.01.2023 has accorded administrative approval for 64.00 Crore approximately for widening of Matanhail Salhawas Kosli road in Jhajjar District km 0.00 to km 19.00 in Jhajjar District under NCRPB Loan Assistance Scheme. The work shall be started after approval of Project Sanctioning and Monitoring Group-I (PSMG-I), NCRPB, New Delhi.

- 2) **Latest position of Internal roads of Jhajjar City is as under:-**
 - a) **Sita Ram Gate to Shamshan Ghat road (Road ID 6585) :-**

This road is in satisfactory condition.
 - b) **Deen Bandhu Sir Chhotu Ram Road (Road ID 8454) :-**

This road is in good condition.
 - c) **Dhaur Beri Chowk to Yadav Dharamshala road via Lt. Chhikara Chowk road (Road ID 8456) :-** Condition of this road is satisfactory and being maintained through routine patch work.
 - d) **Silani Gate to Kuldeep Chowk road (Road ID 8457) :-** Condition of this road is motorable and being maintained through routine patch work.
 - e) **Ambedkar Chowk to Govt. Girls High School road (Road ID 8458) :-** The Hon'ble C.M. has announced in Haryana Vidhan Sabha Session that repair of roads upto Rs. 25.00 Crore will be carried out in all the constituencies as per the recommendations of respective MLAs. Accordingly, Smt. Geeta Bhukkal, MLA Jhajjar has forwarded a list of roads. This road has been taken in the list. The rough cost estimate for Improvement by providing 30mm thick BC for this road has been uploaded on HEW portal and is under examination. The same will be sent to Govt. for seeking administrative approval shortly.

- f) **NH-71 to Rao Tula Ram Chowk road (Road ID 8459) :-** Condition of this road is motorable and being maintained through routine patch work.
 - g) **NH-71 to Lt. Chhikara Chowk along Stadium Jhajjar road (Road ID 10011) :-** Condition of this road is motorable and being maintained through routine patch work.
 - h) **Old NH-71 road passing through Jhajjar city from Km. 388.650 to 392.750 (Road ID 10013) :-** Condition of this road is motorable and being maintained through routine patch work. However, the Rough Cost Estimate for amounting to Rs. 392.75 Lacs has been sent to Govt. vide UO No. 15493 Dated 25.01.2023 for seeking administrative approval (under G-20). Tender for this work is under process and will be allotted shortly.
- 3) **Road from Dadri chwok to Ramilla ground via Ambedkar chowk road (Diversion road to Ramlila ground):-** This road is falls under MLA priority list of Jhajjar Constituency. The road is in motorable condition and presently it is maintained through routine patch work. Administrative Approval for this road improvement amounting to Rs. 867.71 Lacs has been granted by Govt. vide memo no. 09/89/2023-3B&R(W) dated 17.02.2023 (under MLA priority list).

- (क) मातनहेल से साल्हावास वाया अकेहड़ी मदनपुर और लदैन सड़क की स्थिति यातायात योग्य है और जिसका रख-रखाव नियमित पैचवर्क के माध्यम से किया जा रहा है। हरियाणा सरकार ने अतिरिक्त मुख्य सचिव चंडीगढ़ यादि क्रमांक 09/266/2022-3 बीएण्डआर(डब्ल्यू) दिनांक 16.01.2023 द्वारा एन.सी.आर.पी.बी. ऋण सहायता योजना के तहत झज्जर जिले में 0.00 किमी से 19.00 किमी तक मातनहेल साल्हावास कोसली सड़क के चौड़ीकरण के लिए लगभग 64.00 करोड़ की प्रशासनिक स्वीकृति प्रदान की है। प्रोजेक्ट स्वीकृति और निगरानी समूह-1 (पी.एस.एम.जी.-1), एन.सी.आर.पी.बी, नई दिल्ली के अनुमोदन के बाद काम शुरू किया जाएगा।
- (ख) झज्जर शहर की आंतरिक सड़कों की स्थिति यातायात योग्य है। झज्जर शहर की सभी सड़कों का रख-रखाव नियमित पैच वर्क के माध्यम से किया जा रहा है।
- (ग) दादरी चौक से रामलीला मैदान वाया अम्बेडकर चौक तक सड़क की स्थिति यातायात योग्य है और जिसका रख-रखाव नियमित पैचवर्क के माध्यम से किया जा रहा है। इस सड़क के सुधार के लिए 867.71 लाख रुपये की प्रशासनिक स्वीकृति सरकार के यादि क्रमांक 09/89/2023-3 बीएण्डआर(डब्ल्यू) दिनांक 17.02.2023 द्वारा प्रदान की गई है। (विधायक की प्राथमिक कार्य सूचि के अंतर्गत)
