# STATEMENT IN RESPECT OF STARRED ASSEMBLY QUESTION NO. 14/15/128 REGARDING THE TOTAL NUMBER OF SERVING IAS AND HCS OFFICERS.

====

- a) The State Government frames policies to govern services conditions of HCS (Executive), HPS, HFS, HCS (Judicial), Group A, B, C, D officials from time to time, while the service conditions of all India Services (IAS, IPS, IFoS) are governed by Government of India. The Haryana Government has framed the Haryana Civil Services (General) Rules, 2016; Haryana Civil Services (Pay) Rules, 2016; Haryana Civil Services Rules (TA) Rules, 2016; Haryana Civil Services (Allowances) Rules, 2016; Haryana Civil Services (Leave) Rules, 2016; Haryana Civil Services (G.P.F) Rules, 2016; Haryana Civil Services (Pension) Rules 2016 and Haryana Civil Services (Government Employees Conduct) Rules, 2016 and Haryana Civil Services (Punishment and Appeal) Rules, 2016 to reform the civil services governed under Government of Haryana. Copies of the rules are published online. Government of Haryana has also issued of the policy/guidelines regarding premature retirement on attaining the age of 50/55 years or on completion of 25 years of qualifying service to reform the civil services vide instructions vide No. 32/06/2018-4GS1 dated 05<sup>th</sup> February, 2019.
- b) The Government Haryana examines and considers proposals received from time to time to determine the hierarchy levels in various Departments/ Boards/ Corporations, for which the State Government has formed a Rationalization Commission, Haryana vide order No. 62/68/2022-3HR1 dated 29.12.2022. The Commission may make recommendations for restructuring of various Government Departments, Boards and Corporations for rationalization of their staff strength.
- c) Sir, the Government of Haryana has various department and subject matter experts are already working in different departments are consultants and further technical experts like Engineers, Architects, Doctors are hired at Class-I officer level and other levels through Haryana Public Service Commission and Haryana Staff Selection Commission or otherwise, as per applicable rules.

Further, subject matter experts to head the Technical or specialist institutes are hired through selection committees formed from time to time. However, using the exact terms of "Lateral Entrants", no such terminology has been used to appoint personnel in the Haryana Government from November, 2014 till to date.

- d) As on date, total 169 IAS officers are serving in the State and 237 HCS (Executive Branch) officers are also serving in the State. Further, Haryana Public Service Commission has recommended 48 candidates for appointment to HCS (Executive Branch) for Register-B (direct recruitment) and appointment of these 48 candidates is under process.
- e) The 15 number of IAS officers are currently on deputation with Central Government and 2 IAS officers are with Union Territory, Chandigarh Administration. The 4 number of HCS (Executive Branch) officers are on deputation with Union Territory, Chandigarh Administration. The list of IAS officers who are on deputation with Central Government with names and deputation department is placed as Annexure-A. A list of HCS (Executive Branch) officers who are on deputation with Union Territory, Chandigarh Administration is placed as Annexure-B.
- f) The total 169 IAS officers are serving in various Ministries of Haryana Government and Boards/Corporations/Departments and a list of these 169 IAS officers alongwith their details and contact numbers is placed at Annexure-C. So far as HCS (Executive Branch) officers are concerned, the total 237 HCS (Executive Branch) officers are serving in various Ministries of Haryana Government and Boards/Corporations/Departments and a list of these 237 HCS (Executive Branch) officers alongwith their details and contact numbers is placed at Annexure-D.

(न्यायिक), ग्रुप-ए, बी, सी, डी अधिकारियों की सेवा शर्तों को नियंत्रित करने के लिए नीतियां बनाती है, जबिक अखिल भारतीय सेवाओं (आई.ए.एस., आई.पी.एस., आई.एफ.एस.) की सेवा शर्तें, भारत सरकार द्वारा शासित हैं। हरियाणा सरकार ने हरियाणा सरकार के अधीन शासित सिविल सेवाओं में सुधार के लिए हरियाणा सिविल सेवा (सामान्य) नियम, 2016, हरियाणा सिविल सेवा (वेतन) नियम, 2016, हरियाणा सिविल सेवा (छट्टी) नियम, 2016, हरियाणा सिविल सेवा (भित्त) नियम, 2016, हरियाणा सिविल सेवा (छट्टी) नियम, 2016, हरियाणा सिविल सेवा (जी.पी.एफ) नियम, 2016, हरियाणा सिविल सेवा (पेंशन) नियम 2016, हरियाणा सिविल सेवा (सरकारी कर्मचारी आचरण) नियम, 2016 और हरियाणा सिविल सेवा (दंड और अपील) नियम, 2016 बनाए हैं। नियमों की प्रतियां ऑनलाइन प्रकाशित की जाती हैं। हरियाणा सरकार ने सिविल सेवाओं में सुधार के लिए 50/55 वर्ष की आयु प्राप्त करने या अर्हक सेवा के 25 वर्ष पूरा करने पर समय पूर्व सेवानिवृत्ति के संबंध में दिनांक 05 फरवरी, 2019 नीति/दिशानिर्देश भी जारी किए हैं।
- ख) हरियाणा सरकार विभिन्न विभागों/बोर्डों/निगमों में पदानुक्रम स्तर निर्धारित करने के लिए समय-समय पर प्राप्त प्रस्तावों की जांच करती है और उन पर विचार करती है, जिसके लिए राज्य सरकार ने आदेश संख्या 62/68/2022-3एचआर1 दिनांक 29.12.2022 द्वारा एक युक्तिकरण आयोग, हरियाणा का गठन किया है। आयोग विभिन्न सरकारी विभागों, बोर्डों और निगमों के कर्मचारियों की संख्या को युक्तिसंगत बनाने के लिए उनके पुनर्गठन के लिए सिफारिशें कर सकता है।
