## **The Reasons for not Holding the Election of Sarpanch**

**\*14/15/196. Shri Pardeep Chaudhry (Kalka).:** Will the Development and Panchayats Minister be pleased to state:-

- a) whether it is a fact that the election for the post of Sarpanch reserved for BC-A category of village Meerpur in block Raipur Rani could not be held; if so, the reasons therefor; and
- b) whether any responsibility for not holding the election has been fixed?

**DEVENDER SINGH BABLI, DEVELOPMENT AND PANCHAYATS MINISTER**

- a) Yes, Sir. The election for the post of sarpanch reserved for BC-A category of village Mirpur in Block Raipur Rani could not be held as no nomination paper was presented for this post.
- b) No, Sir. Since no nomination paper was received, question of fixing responsibility for not holding the election does not arise.

- क) हां, श्रीमान, ग्राम पंचायत मीरपुर खण्ड रायपुररानी के सरपंच पद के लिए चुनाव नहीं हो सका क्योंकि इस पद के लिये कोई नामांकन पत्र दाखिल नहीं किया गया ।
- (ख) नहीं, श्रीमान, क्योंकि कोई नामांकन पत्र प्राप्त नहीं हुआ, अतः चुनाव न करवाये जाने की जिम्मेवारी निर्धारण करने का प्रश्न उत्पन्न नहीं होता ।
