

### NOTE FOR THE PAD

Bhagat Phool Singh, Government Medical College for Women, Khanpur Kalan, Sonapat was established in the year 2011. The college was issued Letter of Permission by MCI on 20.06.2012 to admit 100 MBBS girl students each year. Presently for academic session 2023-24, it has 120 MBBS seats, total of 77 Diploma, DNB and MD seats (27 MD/MS seats). Affiliated teaching hospital has about 600 beds equipped with all modern facilities. The Medical College is functional under the Department of Medical Education, Government of Haryana and is affiliated to Pt. B.D. Sharma University of Health Sciences, Rohtak, Haryana, and is recognized by National Medical Commission.

The current vacancy status of Doctors & Paramedical Staff of BPSGMC, Khanpur Kalan, Sonapat is as under:-

The posts of the doctors of Cardiologist, Oncologist and Neurosurgeon are already sanctioned in the Institute. These are super specialist posts and are lying vacant. Efforts are being made to fill up these posts from time to time by advertising the same at the level of Government as well by the institute (**Annexure-I**), but no application has been received against the above mentioned specialties. Previously, one Cardiologist Dr. Rohit Walia had joined the Institute but he resigned from the post after about 6 months from his joining. However, if the patients pertaining to any super specialty visit the hospital, then treatment, whichever is possible at the institutional level, is given to the patient. The

vacancy position of faculty of Super-specialty Departments is being sent to the Government from time to time. The cancer treatment at the level of Institute is being provided by the various departments.

At present in two department i.e. Pediatric Surgery and Urology the services of super-specialty treatment are being provided to the patients. The powers to fill up the posts of Senior Residents have been delegated to the Medical College and efforts are being made to fill up these posts from time to time by advertising the same at the *level* of Institute. The walk-in-interviews are being held regularly. On 17.08.2023 the interview for the post of Senior Residents/Tutor has been done and about 90 candidates have applied against the advertised posts and out of these 29 candidates have been selected against the advertised posts in various specialties, however, in the department of Neurosurgery, Oncology and Cardiology no candidates had applied.

For the appointment of Doctors at various GMC's in the State of Haryana, the Govt. has formulated a policy namely "*Appointment of contractual faculty members in Government Medical, Dental and Nursing Colleges policy, 2023*" and presently the same is awaiting approval of Finance Department. As and when the policy is notified, the vacant posts of faculty in various super-specialties and broad specialties in all the GMC's of the State shall be recruited on contractual basis in accordance with the norms set by NMC.

For appointment of Paramedical Staff in BPS GMC, Khanpur Kalan, Sonapat, the requirement has already been conveyed to Haryana Staff Selection Commission vide letter dated 05.01.2023 and the recruitment for the same is in process and as & when the results are announced, vacant posts shall be filled up.

## पैड के लिये नोट

भगत फूल सिंह, राजकीय महिला कालेज खानपुर कलां, सोनीपत की स्थापना वर्ष 2011 में की गई थी। कालेज को प्रत्येक वर्ष 100 एम0बी0बी0एस0 छात्राओं को प्रवेश देने के लिये एम0सी0आई0 द्वारा 20.06.2012 को अनुमति पत्र जारी किया गया था। वर्तमान में शैक्षणिक सत्र 2023-2024 के लिये, इसमें 120 एम0बी0बी0एस0 सीटें, कुल 77 डिप्लोमा, डी0एन0बी0 और एम0डी0 सीटें (27 एम0डी0/एम0एस0 सीटें) हैं। संबंधित शिक्षण अस्पताल में सभी आधुनिक सुविधाओं से सुसज्जित लगभग 600 बिस्तर हैं। यह मैडिकल कालेज हरियाणा सरकार के चिकित्सा शिक्षा विभाग के तहत कार्यरत है और इसे पंडित बी0डी0शर्मा स्वास्थ्य विज्ञान विश्वविद्यालय, रोहतक हरियाणा और राष्ट्रीय चिकित्सा आयोग द्वारा मान्यता प्राप्त है।

भगत फूल सिंह, राजकीय महिला कालेज खानपुर कलां, सोनीपत में डाक्टरों और पैरामैडिकल स्टाफ की वर्तमान रिक्त स्थिती इस प्रकार है:-

संस्थान में कार्डियोलोजिस्ट, आन्कोलाजिस्ट और न्यूरोसर्जन डाक्टरों के पद पहले से ही स्वीकृत हैं। ये सुपर स्पेशलिस्ट पद हैं और खाली पड़े हैं। इन पदों को समय-समय पर शासन स्तर के साथ-साथ संस्थान (अनुलग्नक-1) द्वारा विज्ञापन देकर भरने का प्रयास किया जा रहा है, लेकिन उपरोक्त वर्णित विशेषज्ञता के लिये कोई आवेदन प्राप्त नहीं हुआ है। इससे पहले, एक हृदय रोग विशेषज्ञ डा0 रोहित वालिया संस्थान में शामिल हुये थे, लेकिन उन्होंने अपनी नियुक्ति के लगभग 6 महीने बाद पद से इस्तीफा दे दिया था। हालाँकि यदि किसी सुपर स्पेशलिटी से संबंधित मरीज अस्पताल में आते हैं, तो संस्थागत स्तर पर जो भी संभव हो, मरीज को उपचार दिया जाता है। सुपर स्पेशलिटी विभागों के संकाय की रिक्त स्थिती समय-समय पर सरकार को भेजी जा रही है। संस्थान के स्तर पर कैंसर का ईलाज विभिन्न विभागों द्वारा उपलब्ध कराया जा रहा है।

वर्तमान में दो विभागों यानी पीडियाट्रिक सर्जरी और यूरोलाजी में मरीजों को सुपर-स्पेशियलिटी उपचार की सेवाएं प्रदान की जा रही हैं। सीनियर रेजिडेंटस के पदों को भरने की शक्तियां मैडिकल कालेज को सौंपी गई हैं और समय-समय पर संस्थान के स्तर पर विज्ञापन देकर इन पदों को भरने के प्रयास किये जा रहे हैं। वाक-इन-इंटरव्यू नियमित रूप से आयोजित किए जा रहे हैं। 17.08.2023 को सीनियर रेजिडेंटस/ट्यूटर के पद के लिये सप्ताहत्कार हुआ है और लगभग 90 उम्मीदवारों ने विज्ञापित पदों के लिये आवेदन किया है और इनमें से 29 उम्मीदवारों को विभिन्न विशेषताओं में विज्ञापित पदों के खिलाफ चुना गया है, हालांकि, विभाग में न्यूरोसर्जरी, आन्कोलाजी और कार्डियोलाजी में किसी भी अभ्यर्थी ने आवेदन नहीं किया था। हरियाणा राज्य में विभिन्न जी0एम0सी में डाक्टरों की नियुक्ति के लिये सरकार ने सरकारी मैडिकल, डेंटल और नर्सिंग कालेजों में संविदा संकाय सदस्यों की नियुक्ति नीती, 2023 नामक एक नीती तैयार की है और वर्तमान में यह वित्त विभाग की मंजूरी का इंतजार कर रही है। जब भी नीति अधिसूचित की जायेगी, राज्य के सभी जी0एम0सी में विभिन्न सुपर-स्पेशियलिटी और व्यापक विशिष्टताओं में संकाय के रिक्त पदों पर एन0 एम0सी0 द्वारा निर्धारित मानदंडों के अनुसार अनुबंध के आधार पर भर्ती की जायेगी। बी0पी0एस0 जी0एम0सी0 खानपुर कलां, सोनीपत में पैरामैडिकल स्टाफ की नियुक्ति के लिये आवश्यकता पहले ही हरियाणा कर्मचारी चयन आयोग को दिनांक 05.01.2023 के पत्र के माध्यम से बता दी गई है और इसके लिये सभी भर्ती प्रक्रिया में है और जब भी परिणाम घोषित होंगे, रिक्त पद भरे जायेंगे।

3. The upper age limit prescribed for appointment to any service or posts shall be relaxed in favour of ex-serviceman to the extent of his military service added by three years provided-
- (a) He has rendered continuous military service for a period of not less than six months before his release; and
  - (b) He was released otherwise than by way of dismissal or discharge on account of misconduct or inefficiency.
4. The applicants who are already in Govt./Semi Govt./Corporation or Autonomous Body Service should send application through their respective Head of Department with 'No Objection Certificate' submitted at the time of interview failing which the applicant will not be allowed/ considered for interview. NOC may not be older than 06 months. Further, the candidature of applicants who have resigned from their posts will be considered if their resignation has been accepted from their employer.


