### **Details Regarding Construction of Five Pond System**

13. SH. SHAMSHER SINGH GOGI (Assandh) :

Will the Development & Panchayats Minister be pleased to state that :-

- a) the number of five pond systems for which the construction works have been started by the Government in Assandh Assembly Constituency from April, 2022 to July, 2023 togetherwith the block wise details thereof;
- b) the time by which the construction of said works is likely to be completed by the Government togetherwith the details thereof;
- c) whether it is a fact that the construction work of the five pond systems have not been started in some blocks of Assandh Assembly Constituency by the Government; if so, the reasons therefor togetherwith the time by which the abovesaid works are likely to be started?

**DEVENDER SINGH BABLI, DEVELOPMENT & PANCHAYATS MINISTER**

- a) Only one work of five pond system in village Risalwa block Assandh was started which has been completed during the period from April, 2022 to July, 2023.
- b) The work is already complete.
- c) Total 13 no. projects of Five/Three Pond System (block Assandh = 3, block Munak = 2, block Chirao = 8) have been completed till date in Assandh Assembly Constituency. Now, works of ponds are being executed by Development & Panchayats Department as deposit works on behalf of Haryana Pond and Waste Water Management Authority (HPWWMA) as per design and drawings issued by them. Presently, “Constructed Wetland Technology” is being executed for treatment of incoming dirty water instead of the erstwhile “Five/Three Pond System”

### पांच तालाब प्रणाली के निर्माण से सम्बन्धित ब्यौरा

#### 13. श्री शमशेर सिंह गोगी (असंध) :

क्या विकास एवं पंचायत मंत्री कृपया बताएंगे कि:-

- (क) असंध विधानसभा निर्वाचन क्षेत्र में अप्रैल 2022 से जुलाई 2023 तक सरकार द्वारा पांच तालाब प्रणाली की संख्या कितनी है जिनके लिए निर्माण कार्य शुरू किया गया है तथा उनका खंड वार ब्यौरा क्या है;
- (ख) सरकार द्वारा उक्त कार्यों का निर्माण कब तक किए जाने की संभावना है तथा उसका ब्यौरा क्या है;
- (ग) क्या यह तथ्य है कि सरकार द्वारा असंध विधानसभा निर्वाचन क्षेत्र के कुछ खंडों में पांच तालाब प्रणाली का निर्माण कार्य शुरू नहीं किया गया है; यदि हां, तो उसके कारण क्या हैं तथा उपरोक्त कार्य कब तक शुरू किए जाने की संभावना है ?

#### देवेन्द्र सिंह बबली, विकास एवं पंचायत मंत्री

- (क) ग्राम रिसालवा खण्ड असंध में पांच तालाब प्रणाली का केवल एक कार्य अप्रैल, 2022 से जुलाई, 2023 की अवधि के दौरान शुरू हुआ था जो की पूर्ण हो चुका है।
- (ख) कार्य पहले से पूर्ण हो चुका है।
- (ग) असंध विधानसभा क्षेत्र में अब तक पांच/तीन तालाब प्रणाली की कुल 13 परियोजनाएँ (खण्ड असंध = 3, खण्ड मुनक = 2, खण्ड चिड़ाओ = 8) पूर्ण हो चुकी हैं। अब, विकास एवं पंचायत विभाग द्वारा हरियाणा तालाब एवं अपशिष्ट जल प्रबंधन प्राधिकरण की ओर से तालाबों के कार्य उनके द्वारा जारी किए गए डिजाइन और ड्राइंग के अनुसार डिपॉजिट वर्क के रूप में क्रियान्वित किये जा रहे हैं। वर्तमान आने वाले गन्दे पानी के उपचार के लिए पूर्ववर्ती "पांच/तीन तालाब प्रणाली" की बजाए "कंस्ट्रक्टेड वेटलैंड टेक्नोलॉजी" क्रियान्वित की जा रही है।
