



## Illegal Possession of Land

### 17. Sh. BISHAN LAL SAINI (Radaur):

Will the Development and Panchayats Minister be pleased to state that:- Will the Development and Panchayats Minister be pleased to state whether it is a fact that the Panchayati land has been illegally possessed by some people in the Rapdi village of Radaur Block in Radaur Assembly Constituency and they are protected by the Panchayat Officer; if so, the details thereof?

Sir,

Details of persons who are in unauthorized possession of Panchayat land in village Rapdi of Block Radaur are as under:-

- (i) Land measuring 3 Marla bearing khasra no.68 is in possession of Lal Singh. Eviction order has been passed already against him and the case is fixed on 09.10.2023 for report of execution of the eviction order.
- (ii) Land measuring 155 sq. yards out of khasra no.97 is in possession of Rajesh Kumar S/o Sh. Raghubir Singh and land measuring 150 sq. feet out of khasra no.34 is in possession of Jai Bhagwan S/o Sh. Nathi Ram. Eviction petitions against them are pending before AC 1<sup>st</sup> Grade-cum SDO(Civil) Radaur.
- (iii) Land of BC Chaupal was encroached upon by Shish Pal S/o Sh. Lal Singh by constructing a wall. Gram Panchayat had issued notices to him and the said unauthorized possession has been removed with police help on 22.08.2023.

No Panchayat Officer is giving any protection to these unauthorized occupants.

## जमीन का अवैध कब्जा

क्या विकास एवं पंचायत मंत्री कृपया बताएं कि रादौर विधानसभा निर्वाचन क्षेत्र में रादौर खंड के रपड़ी गांव में कुछ लोगों द्वारा पंचायती भूमि का अवैध कब्जा कर लिया गया है तथा उनको पंचायत अधिकारी का संरक्षण प्राप्त है; यदि हां, तो उसका ब्यौरा क्या है?

श्रीमान् जी,

खण्ड रादौर के गांव रपड़ी में जिन व्यक्तियों ने पंचायत भूमि पर अनाधिकृत कब्जा कर रखा है, उनका विवरण इस प्रकार है:-

- (i) खसरा नंबर 68 में से 3 मरला भूमि लाल सिंह के कब्जे में है। उसके खिलाफ बेदखली आदेश पहले ही पारित किया जा चुका है और बेदखली आदेश के क्रियान्वयन की रिपोर्ट के लिए मामला 09.10.2023 को निश्चित है।
- (ii) खसरा नंबर 97 में से 155 वर्ग गज भूमि राजेश कुमार पुत्र श्री रघुबीर सिंह के कब्जे में है और खसरा नंबर 34 में से 150 वर्ग फीट भूमि जय भगवान पुत्र श्री नाथी राम के कब्जे में है। उनके खिलाफ बेदखली याचिकाएं सहायक कलैक्टर प्रथम श्रेणी एवं एस0डी0ओ0 (सिविल) रादौर के समक्ष लंबित हैं।
- (iii) बी0सी0 चौपाल की भूमि पर शीश पाल पुत्र श्री लाल सिंह ने दीवार बनाकर अतिक्रमण कर लिया था। ग्राम पंचायत ने उसे नोटिस जारी किये थे और दिनांक 22.08.2023 को पुलिस की मदद से उक्त अनाधिकृत कब्जे को हटा दिया गया है।

कोई भी पंचायत अधिकारी इन अनाधिकृत कब्जाधारियों को कोई संरक्षण नहीं दे रहा है।
