

Functioning of Water Treatment Plant

5. **SH. PARDEEP CHAUDHRY (Kalka) :** Will the Public Health Engineering Minister be pleased to state:-

- a) whether it is a fact that the water treatment plant was constructed in village Bhrauli of Barwala Block to check flow of dirty water in the river; if so, the total expenditure incurred on the said project; and
- b) whether the said water treatment plant is functioning or not?

DEVENDER SINGH BABLI, DEVELOPMENT & PANCHAYATS MINISTER

a) Yes Sir. Initially there was a proposal to construct a treatment plant with Constructed Wetland Technology in village Bharauli Block Barwala of district Panchkula to check flow of dirty water in Ghaggar river as per the guidelines of the NGT. Now, the work will be completed soon after arranging the Administrative Approval. No expenditure has been made till date on this item.
