Sir, from November 2019 to November 2023, total 542 cases have been registered by Anti Corruption Bureau, Haryana and 189 cases by Haryana Police Department under the Prevention of Corruption Act-1988 in various Departments, Boards and Corporations in the State. The status/level of investigation of these cases is enclosed as **Annexure "B"**. The details of the year-wise & individual cases are enclosed as **Annexure "C"**.
