Administrative Approval of Block Office Building

- 19. SH. AMARJEET DHANDA (Julana): Will the Deputy Chief Minister to be pleased to state:
 - a) whether it is a fact that the technical approval of construction of new building of Julana Block Office has been given by Chief Engineer Panchayati Raj vide letter no. KPRC-2023/8336 Dated 17/03/2023, but its administrative approval has not been granted so far; and
 - b) if so, the time by which the above said administrative approval is likely to be granted?

a) & b) Yes, Sir. Technical approval for construction of new building of Julana block office was initially granted on 07-03-2023. However the department has decided to increase the scope of work and add more rooms and facilities in the standard design. Consultation with the Chief Architect's office is being done to finalize the revised drawings. Administrative approval is likely to be granted by 31-03-2024.

क) व ख) हाँ, श्रीमान्, जुलाना ब्लॉक कार्यालय के नए भवन के निर्माण के लिए तकनीकी मंजूरी पहले दिनांक 07.03.2023 को दी गई थी। हालाँकि, विभाग ने कार्य का दायरा बढ़ाने का निर्णय लिया है और मानक डिजाइन में अधिक कमरे व सुविधाएं जोडी गई हैं। संशोधित ड्रांईग को अंतिम रूप देने के लिए मुख्य वास्तुकार कार्यालय के साथ परामर्श किया जा रहा है। प्रशासकीय स्वीकृति दिनांक 31.03.2024 तक जारी किए जाने की संभावाना है।
