#### 37. Smt. Geeta Bhukkal (Jhajjar)

Will the Development and Panchayats Minister be pleased to state:-

- a) Whether it is fact that there is lack of facilities in cremation grounds of villages of Jhajjar Assembly Constituency i.e. Guddha, Matanhail, Bhurawas, Reduwas, Ladain, Mundsa, Rudiawas, Kondrawali, Dhanirwas, Sunderheti, Bambulia, Dhania, Jhanswa, Bhadana and Jhajjar City; and
- b) if so, the time by which facilities are likely to be provided in the cremation grounds of abovesaid villages under Shiv Dham Yojana of Government?

#### DEVENDER SINGH BABLI, DEVELOPMENT & PANCHAYATS MINISTER

a) Government has undertaken to provide minimum facilities like Boundary Wall, Shed, Rasta & Drinking Water in the selected cremation grounds used by villagers. The details of facilities which are available/unavailable in the cremation grounds of the above mentioned villages are as under:-
