- a) The Haryana Staff Selection Commission has issued one advertisement for Group-B posts and twelve advertisements for Group C posts from October 2019 to November, 2023. The category-wise details of advertisement and time of publication, is placed at **Annexure-A**.
- b) The number of posts cancelled is 8937, out of which 7628 posts were re-advertised by the Haryana Staff Selection Commission. The categorywise data of all the above said posts together with reasons of cancellation is placed at **Annexure-B.**
- c) A total of 409 court cases relating to the above said posts have been decided by the Hon'ble High Court. The categorywise details togetherwith reasons thereof are placed at **Annexure-C.**
- d) The Haryana Staff Selection Commission has made 12,159 recruitments for the above said posts and out of the total 60785 Group-C posts advertised between October, 2019 to November, 2023, recruitments for 39,519 posts are yet to be finalised.
