

## The Details of Paper Leak Cases

Will the Chief Minister be pleased to state:-

- a) the name of the posts for which the examinations paper have been conducted by the Haryana Public Service Commission and Haryana Staff Selection Commission have been leaked from the year 2014 to 2023-24 in the State together with the year-wise and paper-wise details thereof;
- b) the names of the recruitments which were cancelled due to leak of their papers together with the details thereof; and
- c) the action taken by the Government against the officers/officials and other accused who were involved in the paper leak case together with the name of said officers/officials and accused alongwith the details thereof?

**Haryana Public Service Commission:-**

There is no proven case of paper leakage. However, regarding the written test for the 383 posts of Veterinary Surgeon (Group-B) in Animal Husbandry & Dairying Department, Haryana on 15.01.2023 some applicants filed CWP No. 2710 of 2023 in the Punjab & Haryana High Court. In compliance of the directions of the High Court on 09.02.2023, the Haryana Public Service Commission requested the Director General of Police, Haryana for conducting an inquiry into the allegation of paper leakage. The investigation is still going on. Since, the inquiry was taking time, the Commission cancelled the said examination vide their Announcement dated 17.11.2023.

**Haryana Staff Selection Commission:-**

Some candidates tried to leak the paper of Gram Sachiv against Advt. No. 09/2019, Cat. No. 01 and of Assistant Linemen against Advt. No. 11/2019, Cat. No. 21 in the year 2019. In the year 2021 some

candidates were found with answer keys of the paper for the post of Male Constable against Advt. No. 04/2020, Cat No. 01. All these papers were cancelled on 16.01.2021, 19.03.2020 and 07.08.2021 respectively by the Haryana Staff Selection Commission. Total 29 FIRs were lodged the details of which is placed at **'Annexure-A'**.

**(C)** No Government Officer/Officials of Haryana Public Service Commission and Haryana Staff Selection Commission have been found involved in a case of paper leakage. Details of accused are at **'Annexure-A'**.

ख) उन भर्तियों के नाम क्या है जोकि उनके पेपर लीक होने के कारण रद्द हुईं तथा इसका ब्यौरा क्या है; तथा

ग) पेपर लीक मामले में शामिल अधिकारियों/कर्मचारियों तथा अन्य अभियुक्तों के खिलाफ सरकार द्वारा क्या कार्रवाई की गई है तथा उक्त अधिकारियों/कर्मचारियों और अभियुक्तों के नाम क्या हैं तथा इसका ब्यौरा क्या है?

### हरियाणा लोक सेवा आयोग:—

पेपर लीक का कोई प्रमाणित मामला नहीं है। हालाँकि, 15.01.2023 को पशुपालन और डेयरी विभाग, हरियाणा में पशु चिकित्सा सर्जन (ग्रुप—बी) के 383 पदों के लिए लिखित परीक्षा थी, कुछ आवेदकों द्वारा पंजाब एवं हरियाणा उच्च न्यायालय, चण्डीगढ़ में याचिका संख्या 2710/2023 दाखिल की हुई हैं। उच्च न्यायालय के निर्देश दिनांक 09.02.2023 की अनुपालना में, हरियाणा लोक सेवा आयोग ने पुलिस महानिदेशक, हरियाणा से पेपर लीक के आरोप की जांच करने का अनुरोध किया है। आयोग ने उनकी घोषणा दिनांक 17.11.2023 के माध्यम से उक्त परीक्षा को रद्द कर दिया, क्योंकि जांच अभी भी जारी है और जांच में समय लग रहा था।

हरियाणा कर्मचारी चयन आयोग:-

कुछ उम्मीदवारों ने वर्ष 2019 में विज्ञापन संख्या 09/2019, श्रेणी संख्या 01 के तहत ग्राम सचिव और विज्ञापन संख्या 11/2019, श्रेणी संख्या 21 के तहत सहायक लाइनमैन के पेपर को लीक करने की कोशिश की। वर्ष 2021 में एस.पी. कैथल को विज्ञापन संख्या 04/2020, श्रेणी संख्या 01 के तहत पुरुष कांस्टेबल के पद के लिए एचएसएससी द्वारा आयोजित पेपर की उत्तर कुंजी के साथ कुछ उम्मीदवार मिले हैं। हरियाणा कर्मचारी चयन आयोग द्वारा ये सभी पेपर क्रमशः दिनांक 16.01.2021, 19.03.2020 और 07.08.2021 को रद्द कर दिए। कुल 29 एफआईआर दर्ज की गई थी, जिनका विवरण 'अनुलग्नक-ए' में दिया गया है।

- (ग) पेपर लीक में हरियाणा लोक सेवा आयोग और हरियाणा कर्मचारी चयन आयोग का कोई भी सरकारी अधिकारी/कर्मचारी शामिल नहीं पाया गया है। आरोपियों का ब्यौरा 'अनुलग्नक-ए' में दिया गया है।
