- माननीय मुख्यमंत्री ने जिला चरखी दादरी में सरकारी मेडिकल कॉलेज के निर्माण के लिए गांव घसोला की 50 एकड़ 1 कनाल 5 मरला भूमि 1 रुपये प्रति एकड़ प्रति वर्ष की दर से 33 वर्षों के लिए लेने के लिए उपायुक्त चरखी दादरी द्वारा प्रस्तुत प्रस्ताव को मंजूरी दे दी है।
- महानिदेशक, विकास एवं पंचायत को इस संबंध में पत्र दिनांक 21.12.2023 द्वारा आदेश जारी करने का अनुरोध किया गया है, ताकि लीज डीड निष्पादित की जा सके।
