Sir, in Ateli Assembly Constituency, Mahila Sanskriti Kendra has not been opened in any village. For opening of Mahila Sanskriti Kendra, renovation of existing building in village Garhi Ruthal is in progress.

Process for tender of material/equipments for Mahila Sanskriti Kendras is under process. Mahila Sanskriti Kendra will be opened as soon as the tender is finalized.

For opening of Mahila Sanskriti Kendra, those Gram Panchayats which pass resolution for existing buildings with 300-600 sq.ft. covered area will be considered.

श्रीमान् जी, अटेली विधान सभा निर्वाचनक्षेत्र के किसी भी गांव में महिला संस्कृति केन्द्र नहीं खोला गया है। महिला संस्कृति केंद्र खोलने हेतु गांव गढ़ी रूथल में मौजूदा भवन में नवीनीकरण का कार्य प्रगति पर है।

महिला संस्कृति केन्द्रों में सामग्री / उपकरणों के लिए निविदा की कार्यवाही प्रक्रियाधीन है। जैसे ही निविदा को अन्तिम रूप दिया जाएगा, महिला संस्कृति केन्द्र खोला जाएगा।
