To Construct the District Development Bhawan

- 78 Smt. Naina Singh Chautala (Badhra): Will the Development & Panchayats Minister be pleased to state:
 - a) the time by which the amount of the budget (SFC & FFC) given on the basis of population is likely to be provided for the newly constituted Gram Panchayats of village Badhra and Hansawas Khurd; and
 - b) the time by which the construction of proposed District Development Bhawan (Jila Parishad office) in Dadri is likely to be started?

DEVENDER SINGH BABLI, DEVELOPMENT & PANCHAYATS MINISTER

- a) Gram Panchayat is eligible for release of SFC and FFC Grant only after the duly elected body is in place. Gram Panchayat yet not elected in village Badhra and Hansawas khurd.
- b) The Architectural Drawing/ Design of proposed Zila Parishad Bhawan are under process of finalization in consultation with o/o Chief Architect, Architectural Department, Haryana. As soon as, the Architectural Drawing and Design are finalized, technical sanction along with administrative approval of proposed Zila Parishad Bhawan will be accorded and construction work is likely to be started upto 31.08.2024.

- (ख) प्रस्तावित जिला परिषद भवन की अर्किटेकचरल ड्रांईग / डिजाईन को मुख्य वास्तुकार, वास्तुकला विभाग, हरियाणा के परामर्श से अंतिम रूप देने की प्रक्रिया चल रही है। जैसे ही अर्किटेकचरल ड्रांईग और डिजाईन को अंतिम रूप दे दिया जाएगा, प्रस्तावित जिला परिषद भवन की तकनीकी स्वीकृति सहित प्रशासकीय स्वीकृति दे दी जाएगी तथा निर्माण कार्य 31.08.2024 तक शुरू होने की संभावना है।
