#### **Introduction to Budget at a Glance 2024-25**

1. Budget at a Glance presents broad aggregates of the Budget 2024-25 of the State in a reader-friendly format. This document shows receipts and expenditure, Fiscal Deficit (FD), Revenue Deficit (RD), Effective Revenue Deficit (ERD), and the Primary Deficit (PD) of the Government of Haryana. Besides, it presents a pictorial account of sources of receipts, their application, the details of debt and deficit indicators, sources of deficit financing and trends and composition of important budgetary variables through charts and graphs.

#### **Macroeconomic and Fiscal Parameters**

- 2. Haryana, which was primarily an agrarian economy in 1966, has undergone significant structural transformation. In 2023-24, the contribution from Primary Sector stood at 18.1 percent with Secondary sector at 29.3 percent and Tertiary sector at 52.6 percent. The Government will continue to provide the necessary impetus to propel growth in Primary sector through diversification of crops and activities to allied sector, in the Secondary sector through the expansion of manufacturing activities and pragmatic use of information technology in Services Sector while continuing to focus on sustainability.
- 3. The Government's commitment to promote balanced economic growth across sectors has resulted in an annual compound growth of 6.1 percent in GSDP from 2014-15 to 2023-24.
- 4. As a result of prudent fiscal management, all fiscal parameters excluding the revenue deficit have been brought within the limits prescribed by the Fifteenth Finance Commission under the FRBM Act. **Fiscal Deficit¹** has been projected at 2.80 percent in RE 2023-24 against the permissible limit of 3.0 percent. In BE 2024-25, it has been estimated at 2.77 percent which is well under the 3.0 percent limit under FRBM Act. **Primary Deficit** is fiscal deficit minus interest payments which is projected at 0.70 per cent of the GSDP in BE 2024-25.
- 5. The overall debt stock has been contained, with debt to GSDP ratio remaining at 26.0 per cent for 2023-24 RE as against the limit of 33.1 per cent of GSDP prescribed by the Fifteenth Finance Commission. For the BE 2024-25 as well, the debt stock is expected to be at 26.15 per cent of GSDP, much below the stipulated limit of 32.8 per cent of GSDP.
- 6. In BE 2024-25, the **Revenue Deficit**<sup>2</sup> has been projected at 1.47 percent against the 2023-24 RE of 1.20 percent of the GSDP. **Effective Revenue Deficit** is a better fiscal indicator, which excludes grants given for creation of capital assets from revenue deficit which is estimated at 0.90 per cent of GSDP in BE 2024-25.

#### **Expenditures and Focus Sectors**

- 7. In BE 2024-25, the total expenditure has been projected to increase to ₹1,89,876.61 crore from ₹1,70,490.84 crore in RE 2023-24, up by 11.37 per cent. Total budget of ₹1,89,876.61 crore consists revenue expenditure of ₹1,34,456.36 crore (70.81%) and capital expenditure of ₹55,420.25 crore (29.19%).
- 8. The firm commitment of the Government to boost investment in agriculture, rural development, health, education, welfare activities and infrastructure for comprehensive socioeconomic growth of the State which is reflected in higher budgetary allocation for these sectors in BE 2024-25.

#### **Revenue Receipts**

9. The Government's Revenue Receipts are anticipated to increase by 10.26 per cent in BE 2024-25 to ₹1,16,638.90 crore from ₹1,05,786.93 crore in RE 2023-24.

#### **Equitable Development through GYAN**

10. The GYAN framework is a guiding principle for Government, which will lay foundation of Viksit Haryana. The framework is based upon four pillars - (i) upliftment of poor (Garib), (ii) providing opportunities for the Youth, (iii) supporting Annadata (Farmers) and (iv) advancement of women (Nari).

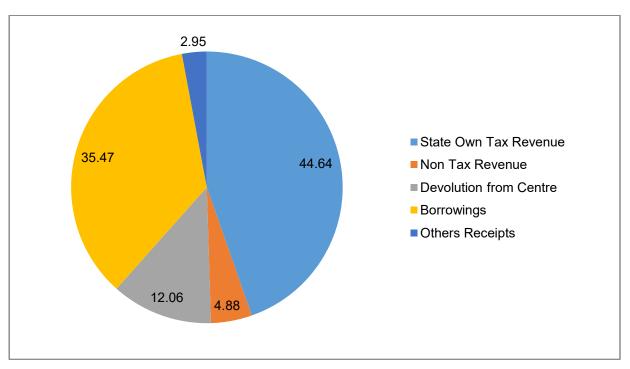

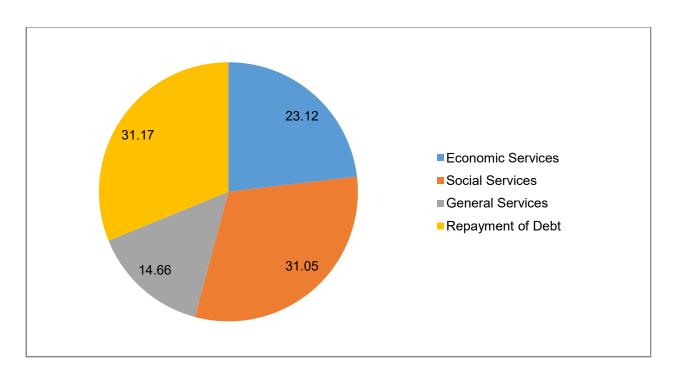

Consolidated Fund 2024-25 BE Rupee comes from (percent)



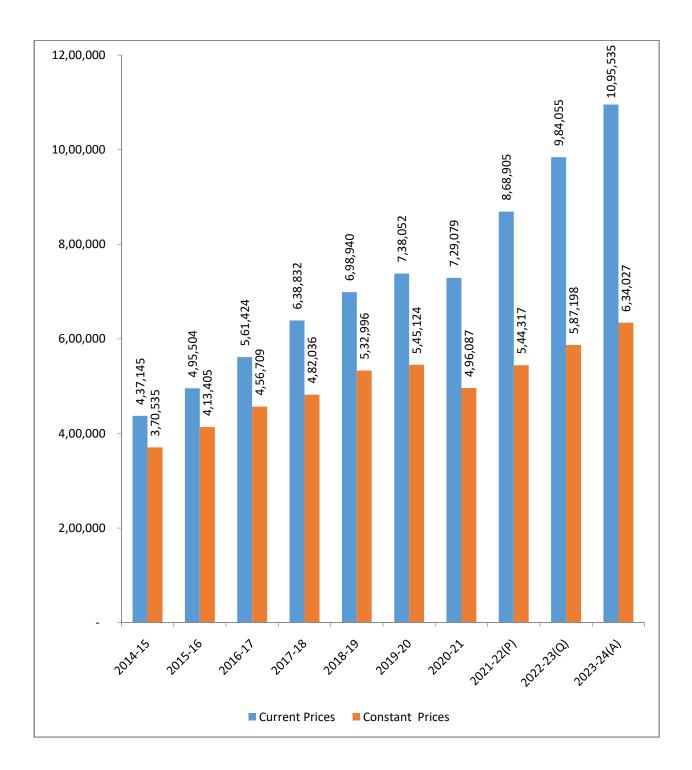

Consolidated Fund (2024-25) Rupee Goes to (percent)



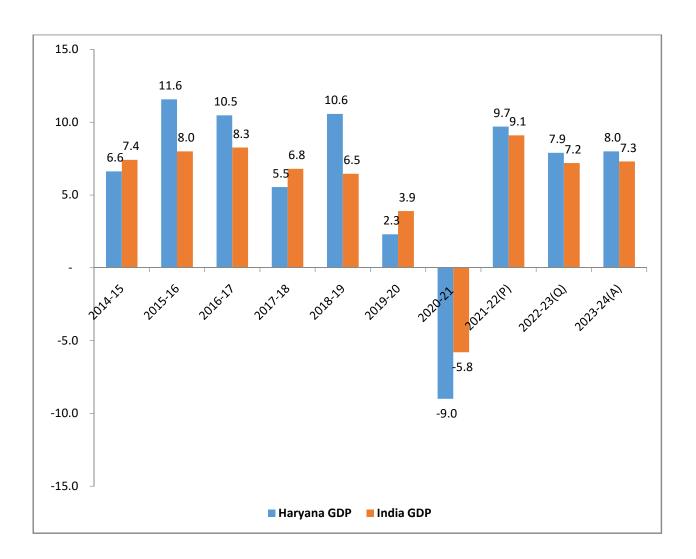

P: Provisional Estimates, Q: Quick Estimates, A: Advance Estimates

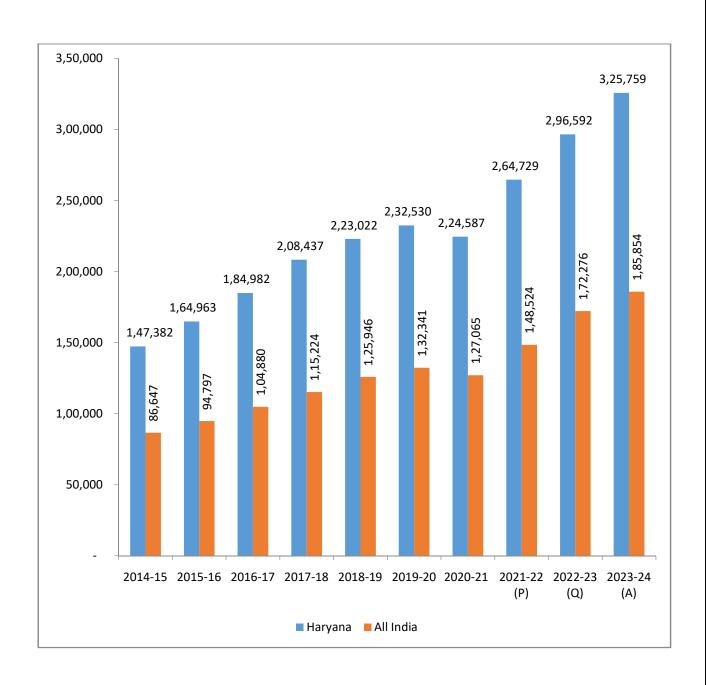
#### GDP growth of Haryana vis-a-vis All India (at Constant 2011-12 Prices) percent

Per Capita Income at Current Prices (in ₹)

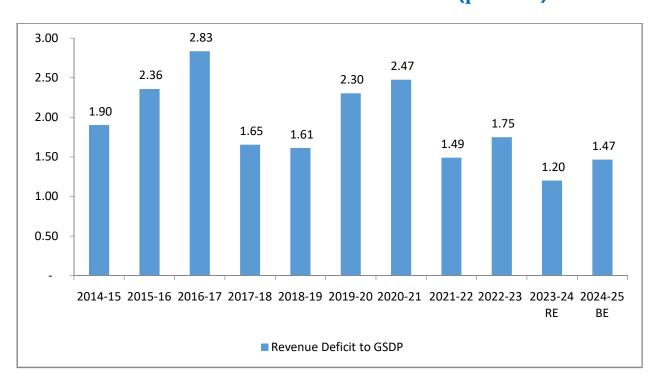

Note: Haryana has the highest Per Capita Income amongst the major States of India.

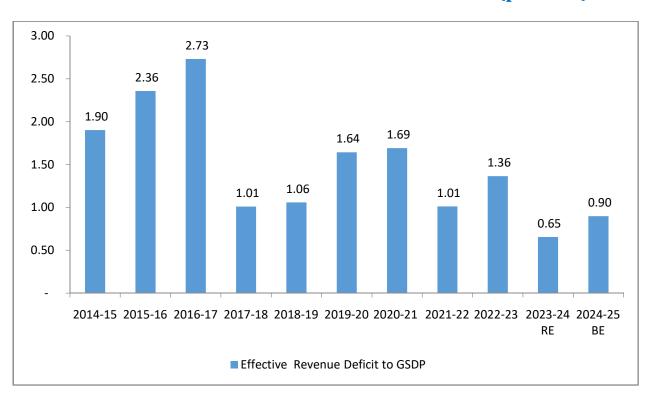

#### **Trend in Revenue Deficit to GSDP (percent)**

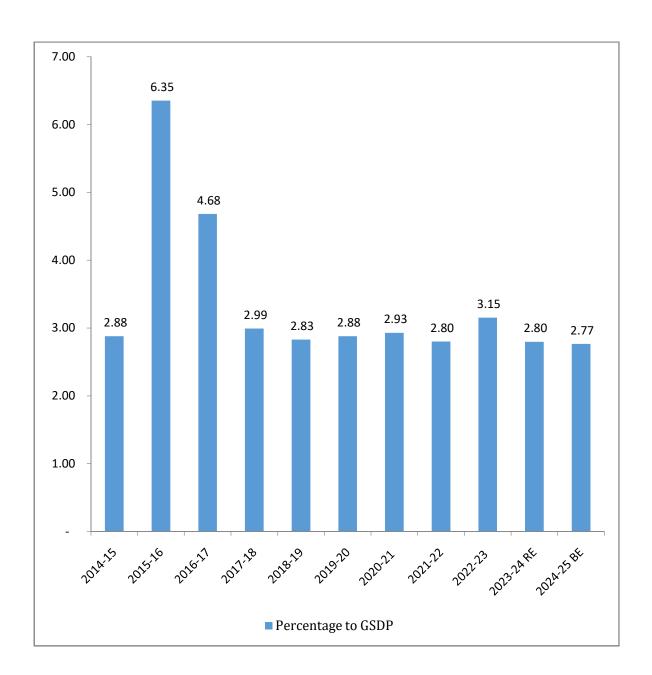

#### **Trend in Effective Revenue Deficit to GSDP (percent)**

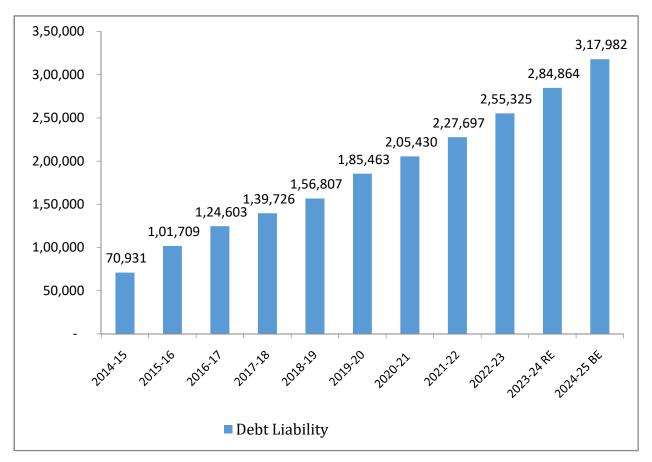

Trend in Fiscal Deficit to GSDP (percent)

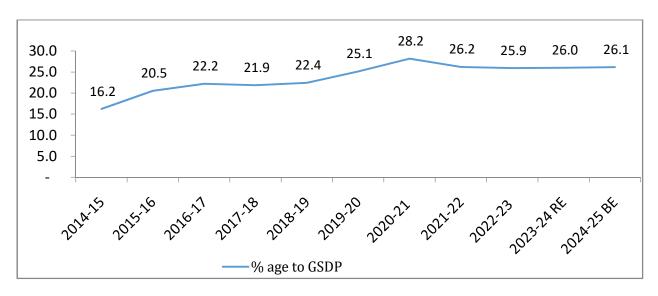

Trend in State Debt Liability (₹crore)

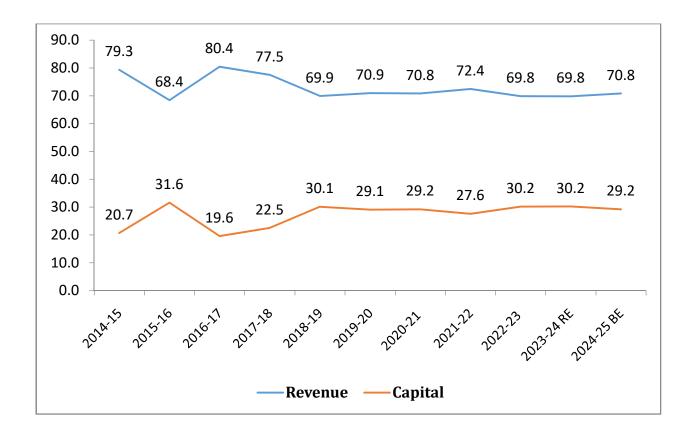

Trend in State Debt Liability to GSDP (percent)

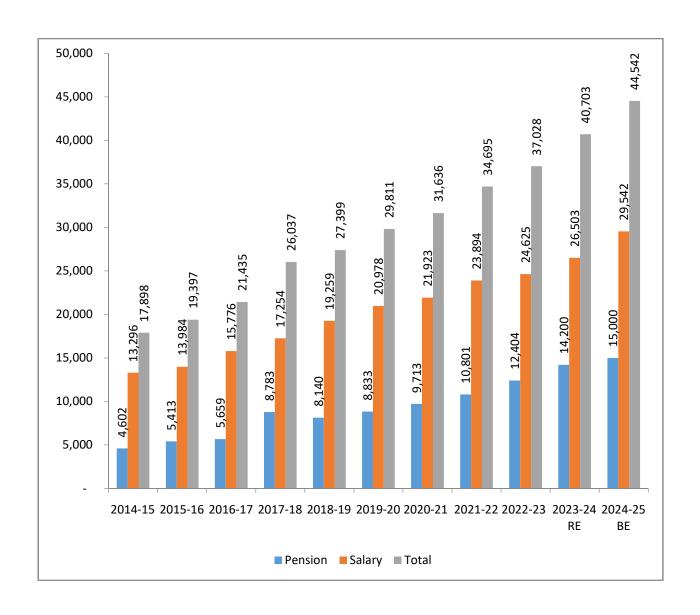

## **Salary and Pensions to Total Revenue Receipts (percent)**

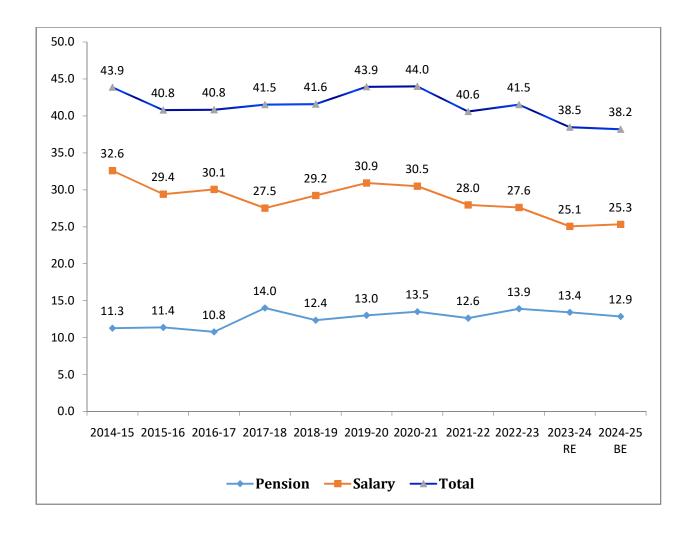
