

Sh. JAGBIR SINGH MALIK (Gohana) :

Will the Development & Panchayats Minister be pleased to state :-

- a) Whether it is a fact that there is problem of stagnant water in the ponds of villages of Gohana Assembly Constituency; if so, the village wise details thereof; and
- b) Whether there is any proposal under consideration of the Government to solve the problem of above said ponds; if so, the time by which the above said problem is likely to be solved?

DEVENDER SINGH BABLI, DEVELOPMENT & PANCHAYATS MINISTER

(a & b) Yes Sir, there is problem of stagnant dirty water in some of the ponds of Gohana Assembly Constituency. Out of total 64 ponds facing this problem, 23 ponds have been taken up for Restoration of Ponds by Haryana Pond and Waste Water Management Authority in coordination with Development and Panchayats Department & Irrigation department. In addition, the work of 1 pond has been completed by Gram Panchayat. The remaining ponds are being taken up as per Action Plan of Haryana Pond and Waste Water Management Authority. The villagewise details are attached as **Annexure-“1”**.

- (क & ख) हाँ श्रीमान् जी, गोहाना विधानसभा क्षेत्र के कुछ तालाबों में गंदे पानी के जमाव की समस्या है। इस समस्या का सामना करने वाले कुल 64 तालाबों में से 23 तालाबों को हरियाणा तालाब और अपशिष्ट जल प्रबंधन प्राधिकरण के समन्वय से विकास एवं पंचायत विभाग और सिंचाई विभाग द्वारा तालाबों के जीर्णोद्धार के लिए लिया गया है। उपरोक्त के अतिरिक्त, 1 तालाब का कार्य ग्राम पंचायत द्वारा पूर्ण कर लिया गया है। शेष तालाबों का कार्य हरियाणा तालाब एवं अपशिष्ट जल प्रबंधन प्राधिकरण की कार्य योजना के अनुसार किया जा रहा है। ग्रामवार विवरण **अनुबंध-“1”** के रूप में संलग्न है।
