To Construct a New Building of SC Chaupal

Sh. Ghanshyam Dass (Yamunanagar):

Will the Development & Panchayats Minister be pleased to state:-

a) whether it is a fact that the building of Scheduled Caste Chaupal in village Kharwan of Yamuna Nagar Assembly Constituency is in dilapidated condition; and

b) if so, whether there is any proposal under consideration of the Government to construct a new building of the said Chaupal togetherwith the time by which the said building is likely to be constructed.

DEVENDER SINGH BABLI, DEVELOPMENT & PANCHAYATS MINISTER

a) Earlier the building of Scheduled Caste chaupal in village Kharwan of Yamunanagar Assembly Constituency was in dilapidated condition But to make the building in useable condition, the repair and painting work of the said chaupal has been done recently by the concerned Gram Panchayat from their own funds.

b) No, Sir. There is no proposal to construct new building of the said chaupal. However, additional one hall room of size 50ft X 35ft is under construction by Gram Panchayat, which is at Roof Level. Funds to the tune of Rs. 16.71 Lakh are needed to complete this hall room. An estimate has been submitted to Government which will be examined.

क्या विकास एवं पंचायत मंत्री कृपया बताएं कि:-

क) क्या यह सच है कि यमुनानगर विधानसभा क्षेत्र के गांव खारवन में अनुसूचित जाति चौपाल का भवन जर्जर हालत में है; और

ख) यदि हां, तो क्या उक्त चौपाल का नया भवन बनाने का कोई प्रस्ताव सरकार के विचाराधीन है तथा उक्त भवन का निर्माण कब तक होने की संभावना है?

क) पहले यमुनानगर विधानसभा क्षेत्र के गांव खारवन में अनुसूचित जाति चौपाल का भवन जर्जर हालत में था, लेकिन हाल ही में भवन को उपयोगी स्थिति में बनाने के लिए उक्त चौपाल की मरम्मत और रंग-रोगन का कार्य संबंधित ग्राम पंचायत द्वारा अपने फंड से करवाया गया है।

ख) नहीं, श्रीमान जी। उक्त चौपाल का नया भवन बनाने का कोई प्रस्ताव नहीं है। हालाँकि, ग्राम पंचायत द्वारा 50 फीट X 35 फीट आकार का एक अतिरिक्त हॉल रूम निर्माणाधीन है, जो छत के स्तर पर है। इस हॉल रूम को पूर्ण करने हेतु 16.71 लाख रुपये की धनराशि की आवश्यकता है। सरकार को एक प्राकलन प्रस्तुत किया गया है, जिसकी जांच की जाएगी।
