THURSDAY, November 7th, 2024

The House met at 10:00 AM in the Jammu and Kashmir Legislative Assembly Hall, Srinagar.

Advocate Abdul Rahim Rather, Hon'ble Speaker in the Chair.

At the commencement of the day's proceedings, the Hon'ble Speaker called Mr. Javid Hassan Baig, Hon'ble Member to initiate the discussion on Motion of Thanks on Lieutenant Governor's Address. Interrupting in the proceedings, Mr. Sunil Kumar Sharma, Leader of Opposition recounted about the Resolution passed yesterday by the House terming it as illegal. Intervening, all the legislators belonging to National Conference joined by the alliance parties and independents stood up from their seats and started protesting/sloganeering against the BJP. In response, all the BJP legislators stood up from their seats and raised anti-Government slogans and demanded revocation of the passed Resolution. Amid chaos, Mr. Khursheed Ahmad Sheikh, Hon'ble Member torched into the Well of the House with a banner demanding the restoration of Article 370, Article 35A and release of all political prisoners resulting in a scuffle when BJP legislators too, stormed into the well trying to take the banner away from Mr. Khursheed Ahmad Sheikh,




Hon'ble MLA. Meanwhile Mr. Khursheed Ahmad Sheikh, Hon'ble Member was marshalled out by Watch & Ward staff of Assembly Secretariat under the directions of the Chair.


Note: At this stage, the House got adjourned at 10:05 AM for fifteen minutes.

The House reassembled at 10:20 AM.

At this stage, the Hon'ble Speaker directed all the Hon'ble Members to resume their seats and maintain sanctity of the House so that the proceedings of the House could be conducted properly but despite the repeated directions from the Chair, all the Members of BJP demanded revocation of the Resolution passed yesterday and continued sloganeering resulting in a complete pandemonium in the House. However, there was a severe turbulence going on betwixt Members of Ruling alliance and BJP. The Hon'ble Speaker while standing from his Chair repeatedly directed the agitating BJP legislators to maintain discipline and observe ethical code of conduct but the directions of the Chair were not honoured.

 **Note:** At this stage, the Hon'ble Members of BJP namely Mr. R. S. Pathania, Mr. Rajiv Jasrotia, Mr. Arvind Kumar Gupta, Mr. Vikram Randhawa, Mr. Satish Kumar Sharma and Mr. Mohan Lal tried to come into the Well of the House were marshalled out under the directions of the Chair.
