PENSION

- i. Rs.50,000/- per month for basic term irrespective of duration;
- ii. Rs.2000/- for every completed year of additional term of membership; and
- iii. Rs.10,000/- per month as Medical Allowance

**Provided that total pension shall not exceed
Rs.75,000/= per month excluding medical allowance.**

FAMILY PENSION

75 % of the Pension admissible to the Ex-Member after his or her death shall be payable to the surviving spouse until he/she does not remarry and after his/her death shall be payable to his/her dependent children (i.e Minor Son or Unmarried Daughter).
