Wednesday, March 19, 2025

The House met today on 19th of March, 2025 at 10.00 AM
in the Jammu and Kashmir Legislative Assembly Hall, Jammu.

**Advocate Abdul Rahim Rather, Hon'ble Speaker in the Chair at
10.00 hours.**

Starred Questions : Out of 33 Starred Questions set down in the
Question list, only 10 questions were called and answered.
Twenty Three (23) Supplementary Questions were also raised
and answers given.

Un-starred Questions: Written replies to 21 un-starred
questions set down in the Question List were distributed among
the concerned Hon'ble Members.

Note 1: After the culmination of the Question Hour, Hon'ble
Speaker referred to the tweet posted by Hon'ble Member, Mr.

Waheed-ur-Rehman Parra (PDP) at 11.57 PM yesterday wherein he alleged that his Cut Motions were deliberately not entertained in respect of few departments under the control of Hon'ble Chief Minister. The Hon'ble Speaker quoted Rule 227 of the Rules of Procedure and Conduct of Business in J&K Legislative Assembly regarding notice of Cut Motions which states as "if notice of a motion to reduce any demand for Grant has not been given three clear days previous to the day, on which the demand is under consideration, any Member may object to the moving of the motion, and such objection shall prevail, unless the Speaker allows the motion to be made" i.e. the Hon'ble Member is allowed to give Cut Motion three days prior to the listing of Grants in the Business. Hon'ble Speaker added that 105 Cut Motions of Hon'ble Member, Mr. Parra's had been admitted. The Chair said the Hon'ble Member to abstain from making such speeches in public for scoring the political gains and asked him to apologize for his remarks. In response, Hon'ble Member, Mr. Waheed-ur-Rehman Parra (PDP) tried to make clarification with regard to the issue. However, Hon'ble Member, Mr. Sajad Gani Lone (PC) requested the Chair to let the Hon'ble Member to clarify his position. Amid upheaval in the House, Hon'ble Members of NC and Congress demanded action



against the Hon'ble Member. Concluding the issue, Hon'ble Speaker directed the Hon'ble Member, Mr. Wahed-ur-Rehman Parra (PDP) to be responsible in future and said that the matter is now closed.

Note 2: At this stage, Leader of Opposition, Mr. Sunil Sharma while addressing the Chair complained that from yesterday our Legislators are not being given chance to spoke on Demands for Grants as compared to the Hon'ble Members from Treasury Benches and requested the Chair to provide opportunity to our Legislators to participate in the discussion. In response, Hon'ble Speaker stated that he will try to accommodate every Member.

Note 3: At this stage, Hon'ble Member, Mr. Mehraj Malik (AAP) informed the House about one officer of the Horticulture Department, Jammu and alleged that corruption charges of two and half crores has been leveled against him. He further added that the said officer is retiring after two months but till date no action has been taken against him. He requested the Government to take notice of this matter.
