**LIST OF AMENDMENTS TO RESOLUTION MOVED BY HON'BLE
CHIEF MINISTER ON 25TH OF SEPTEMBER, 2026 IN THE HOUSE**

1. Mr. Javid Hassan Baig to move:-

After the words "full statehood to Jammu and Kashmir" the following words be inserted:

"along with restoration of Article 370 and the constitutional protections formerly available under Article 35A."

2. Mr. Nizam Ud Din Bhat to move:-

At the end of the resolution delete the punctuation mark full stop (.), and thereafter the following words be added:

"as a reminder to respect its own commitments made at various forums and to the deprived people of Jammu and Kashmir."

3. Mr. Muzaffar Iqbal Khan to move:-

After the words "immediate and urgent restoration of full statehood to Jammu and Kashmir" the following words be inserted:

"and further calls upon the Government of India to restore to Jammu and Kashmir its full constitutional and political status as it existed prior to 5th August, 2019, including Article 370 of the constitution of India and the constitutional safeguards and protections associated with Article 35A, and to restore the special constitutional relationship between Jammu and Kashmir and the Union of India that existed prior to the constitutional changes made in August 2019"

4. Mr. Tanvir Sadiq to move:-

After the words "6th November, 2024" the following words be inserted:

"this House reaffirms its commitment to the restoration of the constitutional guarantees embodied in Articles 370 and 35A, as they existed prior to 5th August 2019, and"

5. Mr. Ajaz Ahmed Jan to move:-

After the words "6th November, 2024" the following words be inserted:

"this House reaffirms its commitment to restore the constitutional and legal position of Jammu and Kashmir as it stood immediately prior to 5th August 2019, including the

constitutional provisions and protections contained in Article 370 and Article 35A."

6. Mr. Waheed Ur Rehman Para to move:-

At the end of the resolution in place of a full stop (.) put a comma (,) and the following words be inserted:

"restore autonomy, besides restoring Articles 370 and 35A in their original form."

7. Aga Syed Muntazir Mehdi to move:-

After the words **"6th November, 2024"** the following words be inserted:

"while expressing its deep anguish and disapproval over the unilateral measures initiated on and after 5 August 2019, which resulted in the cessation of Article 370 and Article 35A, and the reorganization of the erstwhile State of Jammu and Kashmir into the Union Territories of Jammu and Kashmir and Ladakh."

8. Mr. Altaf Ahmad Wani to move:-

At the end of the resolution, in place of a full stop (.) put a comma (,) and the following words be inserted:

"this House also reaffirms its commitment to restore the constitutional position that existed prior to 5th August, 2019 including Article 370 and 35A."

9. Mr. Hilal Akbar Lone to move:-

The following words be added

"include the restoration of Articles 370 and 35A."

10. Ch. Mohammad Akram to move:-

After the words **"6th November, 2024"** the following words be inserted:

"this House also reaffirms its commitment to restore the constitutional position of Jammu and Kashmir as it existed prior to 5th August, 2019 and Article 35A."
