**Tuesday, March 31<sup>st</sup>, 2026**

The House met today on 31<sup>st</sup> of March, 2026 at 10:00 A.M. in the Jammu and Kashmir Legislative Assembly Hall, Jammu.

 **Advocate Abdul Rahim Rather, Hon'ble Speaker in the Chair.**

 As soon as the Hon'ble Speaker took the Chair, Hon'ble Member, Justice Hasnain Masoodi supported by all the Hon'ble Members of Ruling Party stood up from their seats while stating that they have submitted an Adjournment Motion regarding withdrawal of security cover from the headquarter of National Conference in Srinagar. In response, Hon'ble Speaker assured them that the issue will be taken up after Question Hour.

**Starred Questions:** 32 Starred Questions set down in the Question list were answered in writing, out of which eleven (11) questions were called and answered orally as well. Fifteen (15) Supplementary Questions were also raised and answers given.

**Un-starred Questions:** Written replies to 43 un-starred questions set down in the Question List were distributed among the concerned Hon'ble Members.

**Note 1:** At this stage, Hon'ble Speaker called Hon'ble Members namely Mr. Nazir Ahmad Khan (NC), Mr. Javed Hassen Baig (NC) and Mr. Payare Lal Sharma (Ind.) to raise their respective questions viz-a-viz A. Q. No. 768 listed at S. No. 2, A. Q. No. 400 at S. No. 3 and A. Q. No. 675 at S. No. 8. However, they were not present in the House.


**Note 2:** At this stage, Hon'ble Member, Mr. Hasnain Masoodi (NC) raised the issue relating to sudden withdrawal of security from the National Conference (NC) headquarter, Nawa-i-Subh, in Srinagar besides, withdrawal of escort from several Kashmir-based Hon'ble Legislators. The entire ruling party Members expressed resentment over the complete removal of the security cover at the Party's headquarters.


Hon'ble Member, Mr. Nazir Ahmad Khan (Gurezi) asserted that since the Lieutenant Governor (LG) holds the Home Department

portfolio, the administration must be held accountable for any untoward incident, resulting from these security lapses.

Hon'ble Member Mr. Nizam-ud-din Bhat (INC) stated that every life is important and deserves protection, noting that the State is obligated to protect all citizens, especially those in public roles. He further asserted that under the Re-organization Act, 2019, Members of this House are at par with Members of Parliament, subsequently requested the Chair to adopt a resolution to restore fair and adequate security arrangements besides, priority should be given to safeguard human lives rather than assets.


Hon'ble Member, Mr. Surjit Singh Slathia (BJP) said that withdrawing security is the concern of everybody across party lines and should be reviewed.


 Hon'ble Member, Mr. Salman Sagar (NC), stated that this move comes only weeks after an assassination attempt on NC President Dr. Farooq Abdullah in Jammu. He further stated that Dr. Abdullah visits the office atleast twice a week and the withdrawal of security significantly heightens the threat level for both leadership and staff. He criticized the administration for what they called a "non-merit-based" approach to security categorization.



Meanwhile, Hon'ble Member Mr. Sajad Gani Lone (PC) accused the National Conference of 'selective outrage', stating that when we tried to bring such issue which is not in our domain, we are not allowed, but why NC Members being allowed to raise the security issues. He urged the aggrieved Members to take their concerns to the Union Home Ministry or the Hon'ble Lieutenant Governor, rather than disrupting House proceedings. In response, Hon'ble Speaker said that every Member is allowed to speak in the House.

Hon'ble Deputy Chief Minister, Mr. Surinder Kumar Choudhary objected the statement made by Hon'ble Member, Mr. Sajad Gani Lone (PC) and said that he is residing in the house of a Cabinet Minister and should leave it.

 Hon'ble Member, Mr. Javed Hassan Baig (NC), stated that the killing of Mr. Sajad Lone's father was the loss for whole Jammu and Kashmir. He further stated that the issue was not about any single party but a collective concern for all.

 Hon'ble Member, Mr. Rafiq Ahmed Naik (PDP) remarked that God is the ultimate saviour and everybody should have faith in Devine. Further stated that even under high security, one can be killed but if God chose to protect anybody, no one can cause harm to him.

While concluding, the Hon'ble Speaker stressed that the security scenario cannot be taken lightly and said "If the holders of the National Flag are not safe, how can the flag itself be safe." He further added, if they do not want to provide security to the legislators then declare Jammu and Kashmir a "risk-free" region or ensure a uniform, merit-based security system. He emphasized that there should be clear norms rather than "pick and choose" policy and asked the concerned security agencies to review the decision immediately. He remarked that those who have survived past security incidents understand the gravity of the threat better than anyone else and stated that past incidents must guide present decisions.

**Note 3:** At this stage, Hon'ble Member Mr. S.S. Slathia (BJP) drew the attention towards the plight of nearly 22,000 account holders of SCARD Bank, whose hard-earned savings are currently withheld. Although, the concerned Minister previously assured that the matter will be resolved, as on date their money remained unreleased. He urged the Chair to recognize the Government's responsibility in ensuring the immediate return of these deposits.

Shamim Firdous** called the attention of Hon'ble Chief Minister (Incharge Planning Development and Monitoring) towards a matter of urgent public importance namely; the situation arising out of refusal by the District Administration Srinagar to utilize CDF for rehabilitation of fire sufferers.


