Will the Minister of MINORITY AFFAIRS be pleased to state:

- (a) whether the Government extends Pre-Post Matric and Merit-cum-Means scholarships to minority students;
- (b) if so, the total number of scholarships in these categories that have been given in the current year;
- (c) the details of the amount released/disbursed by Government of India for Post Matric scholarship for minorities in different States during the last three years and the current year, State-wise;
- (d) the amount per student disbursed thereon, State-wise; and
- (e) whether the Government proposes to revise the scholarship amounts in accordance with the rising fee in universities and increase in living cost and if so, the details thereof?

**ANSWER**

(a) & (b) : Ministry of Minority Affairs implements three Scholarship Schemes viz. Pre-matric, Post-matric and Merit-cum-Means based Scholarship Schemes for educational empowerment of six notified minority communities viz. Muslim, Christian, Sikh, Buddhist, Jain and Parsi (Zoroastrians) across the country. The process for disbursement of Scholarship entails inviting applications online, verification and drawing up the eligible list, which is normally completed in the 3<sup>rd</sup> quarter of this financial year as was done in 2017-18. The same process is to be followed in 2018-19.

(c) & (d): The details of the physical allocation and achievement along with amount of scholarships released under Post-matric Scholarship Scheme to the minorities in different States/UTs during the last three years and the current year is annexed. The rates of scholarship under the scheme is as under:
