Statement in reply to part (a) to (e) of the Lok Sabha Starred Question No.127 for 26.07.2018 regarding "Renaming of Airports":

- (a): As a general practice, the requests for naming/renaming of airports are considered based on the recommendations of the concerned State Government, supported by a resolution passed in the State Legislative Assembly.
- (b): During the last three years, including the current year, the Union Cabinet has approved the proposal for renaming of the Agartala Airport in Tripura.
- (c) & (d): Although, there are no written instructions/guidelines/policy for naming/renaming of airports in the country, as a general practice, the requests for naming/renaming of airports are considered based on the recommendations of the State Government concerned, supported by a resolution passed in the State Legislative Assembly.
- (e): The Union Cabinet has approved the proposal for renaming of the Agartala Airport in Tripura. Proposals for renaming of various Airports have also been received from several State Governments including the Govt. of Maharashtra. No definite time-frame has been fixed in the matter as it involves consultations with the concerned Ministries and final approval by the Union Cabinet.
