Environmental Clearance for Construction of New Dam

- (a) the details of proposals for construction of new dams for which environmental clearance had been given in the last five years, State/UT-wise; and
- (b) the details of pending proposals for new dams along with the present status of the same, State/UT-wise?

- (a) Total twenty seven (27) proposals for construction of dams were granted environmental clearance during the last five years. List of these proposals is annexed (Annexure I).
- (b) Twenty (20) number of proposals for construction of dams are pending in this Ministry of Environment, Forest & Climate Change for environmental clearance. State wise detail of these projects with the present status is annexed (Annexure II).
