- (a) the number of proposals received by the Union Government from the State Government of Rajasthan regarding various projects and developmental works during the last three years along with the status of these proposals and the amount involved therein, proposal/project-wise;
- (b) the reasons for delay in sanctioning the said proposals along with the action taken to expedite the same;
- (c) whether any time-limit has been fixed in this regard and if so, the details thereof;
- (d) whether the developmental works get disrupted due to delay in disposal of the proposals; and
- (e) if so, the manner in which cost escalation in works is adjusted?
