5. LEGISLATIVE BUSINESS-Consideration of Rajya Sabha Amendments

(1)BILL- National Medical Commission Bill, 2019 BILL NO-185-C of 2019 DR. HARSH VARDHAN to move that the following amendments made by Rajya Sabha in the Bill to provide for a medical education system that improves access to quality and affordable medical education, ensures availability of adequate and high quality medical professionals in all parts of the country; that promotes equitable and universal healthcare that encourages community health perspective and makes services of medical professionals accessible to all the citizens; that promotes national health goals; that encourages medical professionals to adopt latest medical research in their work and to contribute to research; that has an objective periodic and

transparent assessment of medical institutions and facilitates maintenance of a medical register for India and enforces high ethical standards in all aspects of medical services; that is flexible to adapt to changing needs and has an effective grievance redressal mechanism and for matters connected therewith or incidental thereto, be taken into consideration:—

- (ii) CLAUSE 37 4. That at page 18, line 24, after the words "qualification to be equivalent", the words "for the purposes of teaching also." be inserted
- (2)BILL-Motor Vehicles (Amendment) Bill, 2019. BILL NO- 142 of 2019 SHRI NITIN GADKARI to move that the following amendments made by Rajya Sabha in the Bill further to amend the Motor Vehicles Act, 1988, be taken into consideration:—
- (i) CLAUSE 30 1. That at page 11, line 25, for the word "consultation", the word "concurrence" be substituted
