  - (iii) SHRIMATI POONAM MAHAJAN to move :- "This House urges upon the Government to- (a) develop a space startup incubation programme as a building block of a strong space startup ecosystem to drive the development of a modern space-based economy in order to realise the potential of creating more than \$10 billion independent space based economy, employing one lakh high skilled engineers and scientists by the year 2025; (b) encourage start-up ideas that are complementary to the Indian Space Research Organisation's roadmap of technologies and capabilities so as to catalyse the space-based technology and services creation in the country; (c) develop a New Space India start-up ecosystem to provide further impetus for Digital India, Make in India and encourage local institutional investment, foreign direct investment, creation of joint ventures, mergers and acquisitions and public listings as the ecosystem matures; (d) constitute a working group to create a New Space India ecosystem consisting of entrepreneurs, investors, lawyers, academicians, scientists and policy makers along with representatives from Antrix Corporation Limited providing a foundation for the working group in making recommendations and carrying forward the New Space India ecosystem towards international vibrancy keeping in mind the fact that the world market size of space economy is \$339 billion - of which the size of a



satellite industry comprising satellite manufacturing, launch industry, satellite services and ground equipment segment is \$261 billion where the India's overall market share is less than one per cent; (e) consider single window clearance for commercialisation and research projects with setting up of the Office of Space Commerce involving all the ministries and departments of Government relevant in upstream and downstream applications of the space sector; and (f) create a corpus fund of rupees one hundred crore to give bridge capital with opportunities for private sector and institutional investors to facilitate participation in New Space India.” Formulation of a New Space India policy with a vision to build a foundation to help India advance in creation of global leaders in space technology and applications.

- (iv) PROF. SAUGATA ROY to move :- “Having regard to the fact that the- (a) oil prices at the international level have been at a historic low since the year 2014; (b) instead of passing on the benefit of the low prices of the oil to the consumer, the Government had increased the excise duty two hundred per cent. on petrol and four hundred per cent. on diesel thereby collecting rupees ten lakh crore by way of excise; and (c) retail price of petrol had crossed rupees eighty per litre and of diesel rupees seventy per litre causing disruption in the economy, this House urges upon the Central Government to reduce excise duties on petrol and diesel so that the consumer may get benefit of low international oil prices.” Central Government to reduce excise duties on petrol and diesel.
- (v) DR. RAMESH POKHRIYAL 'NISHANK' to move :- "Taking into consideration that – (a) every independent nation is recognised and identified by its unique national language, national flag, national Constitution and national emblem; (b) the intention of the framers of the Constitution was to promote the progressive use of Hindi language in Devanagari Script for official purposes within a period of fifteen years; (c) Hindi language, being the richest language in the world with more than four lakh words, is spoken and understood by a major chunk of our population across India and also in many countries of the world; and (d) inspite of directive for development of the Hindi language under article 351 of our Constitution, even after more than seventy years of independence, English language is still being used for official purposes of the Union, in all proceedings in the Supreme Court and High Courts and as an authoritative text of Bills introduced or passed by Parliament and orders, rules, regulations and bye-laws issued under the Constitution or any law made by Parliament, this House urges upon the Government to implement the provisions of articles 343 to 349 of the Constitution, bring forward a suitable legislation for declaring the Hindi language in Devanagari Script as the National language of India and take immediate concrete measures for all-round development of Hindi language with a view to preserve and strengthen the unity and integrity of our nation." Need for suitable legislation for declaring the Hindi language in Devanagari Script as the National language of India and measures for its all-round development.
