#### 1. MESSAGES FROM RAJYA SABHA

- (1) **SECRETARY GENERAL** to report three messages from Rajya Sabha regarding the Unlawful Activities (Prevention) Amendment Bill, 2019, the Repealing and Amending Bill, 2019 and the Code on Wages, 2019.

#### 2. REPORTS ON THE PARTICIPATION OF INDIAN PARLIAMENTARY DELEGATIONS AT THE STATUTORY ASSEMBLIES OF THE INTER-PARLIAMENTARY UNION (134TH TO 140TH STATUTORY ASSEMBLIES)

- (1) **SECRETARY GENERAL** to lay on the Table Hindi and English versions of the Seven Reports on the participation of Indian Parliamentary Delegations at the 134th to 140th Statutory Assemblies of the Inter-Parliamentary Union.

#### 3. MOTION FOR ELECTION TO THE COURT OF ALIGARH MUSLIM UNIVERSITY

- (1) **SHRI RAMESH POKHRIYAL 'NISHANK'** to move the following:- "That in pursuance of sub-clause (xxiv) of clause 1 and clause 2 of Statute 14 of the Statutes of Aligarh Muslim University Act, 1920, the members of this House do proceed to elect, in such manner as the Speaker may direct, six members from amongst themselves to serve as members of the Court of the Aligarh Muslim University, subject to the other provisions of the said Statutes."

#### 4. LEGISLATIVE BUSINESS

- (1) (i) Bills to be introduced

(i) **BILL-The Supreme Court (Number of Judges) Amendment Bill, 2019 SHRI RAVI SHANKAR PRASAD** to move for leave to introduce a Bill further to amend the Supreme Court (Number of Judges) Act, 1956.

(ii) **BILL-The Chit Funds (Amendment) Bill, 2019 SHRIMATI NIRMALA SITHARAMAN** to move for leave to introduce a Bill further to amend the Chit Funds Act, 1982.

## 5. LEGISLATIVE BUSINESS-Consideration of Rajya Sabha Amendments

(1) **BILL- National Medical Commission Bill, 2019 BILL NO- 185-C of 2019 DR. HARSH VARDHAN** to move that the following amendments made by Rajya Sabha in the Bill to provide for a medical education system that improves access to quality and affordable medical education, ensures availability of adequate and high quality medical professionals in all parts of the country; that promotes equitable and universal healthcare that encourages community health perspective and makes services of medical professionals accessible to all the citizens; that promotes national health goals; that encourages medical professionals to adopt latest medical research in their work and to contribute to research; that has an objective periodic and transparent assessment of medical institutions and facilitates maintenance of a medical register for India and enforces high ethical standards in all aspects of medical services; that is flexible to adapt to changing needs and has an effective grievance redressal mechanism and for matters connected therewith or incidental thereto, be taken into consideration:—

(i) **CLAUSE 4** 1. That at page 3, line 27, for the word “fourteen”, the word “twenty-two” be substituted. 2. That at page 4, line 16, for the word “six”, the word “ten” be substituted. 3. That at page 4, line 20, for the word “five”, the word “nine” be substituted

(ii) **CLAUSE 37** 4. That at page 18, line 24, after the words “qualification to be equivalent”, the words “for the purposes of teaching also.” be inserted

(2) **BILL-Motor Vehicles (Amendment) Bill, 2019.**

**BILL NO- 142 of 2019 SHRI NITIN GADKARI** to move that the following amendments made by Rajya Sabha in the Bill further to amend the Motor Vehicles Act, 1988, be taken into consideration:—

(i) **CLAUSE 30** 1. That at page 11, line 25, for the word “consultation”, the word “concurrence” be substituted

(ii) **CLAUSE 34** 2. That at page 14, line 2, for the word “consult”, the words “seek concurrence of” be substituted.

(iii) **CLAUSE 77** 3. That at page 37, line 24, for the word, bracket and figure “sub-section (4)”, the word, bracket and figure “sub-section (1)” be substituted.

## 6. Bills for consideration and passing

(1) **SHRI RAVI SHANKAR PRASAD** to move that the Bill further to amend the Supreme Court (Number of Judges) Act, 1956, be taken into consideration

- (2) **SHRI THAAWAR CHAND GEHLOT** to move that the Bill to provide for protection of rights of transgender persons and their welfare and for matters connected therewith and incidental thereto, be taken into consideration.
- (3) **DR. HARSH VARDHAN** to move that the Bill to constitute National Surrogacy Board, State Surrogacy Boards and appointment of appropriate authorities for regulation of the practice and process of surrogacy and for matters connected therewith or incidental thereto, be taken into consideration.

## 7. RESOLUTION

- (1) **SHRI AMIT SHAH** to move the following Resolution:- "That the President of India has referred the Jammu and Kashmir Reorganisation Bill, 2019 to this House under the proviso to article 3 of the Constitution of India for its views as this House is vested with the powers of the State Legislature of Jammu and Kashmir, as per proclamation of the President of India dated 19th December, 2018. This House resolves to express the view to accept the Jammu and Kashmir Reorganisation Bill, 2019."
