2. LEGISLATIVE BUSINESS

- (1) Bills to be introduced

(i) **BILL-The National Capital Territory of Delhi (Recognition of Property Rights of Residents in Unauthorised Colonies) Bill, 2019. SHRI HARDEEP SINGH PURI** to move for leave to introduce a Bill to provide special provisions for the National Capital Territory of Delhi for recognising the property rights of resident in unauthorised colonies by securing the rights of ownership or transfer or mortgage in favour of the residents of such colonies who are possessing properties on the basis of Power of Attorney, Agreement to Sale, Will, possession letter or any other documents including documents evidencing payment of consideration and for the matters connected therewith or incidental thereto.

(ii) **BILL-The Dadra and Nagar Haveli and Daman and Diu (Merger of Union Territories) Bill, 2019. SHRI AMIT SHAH** to move for leave to introduce a Bill to provide for merger of Union territories of Dadra and Nagar Haveli and Daman and Diu and for matters connected therewith. ALSO to introduce the Bill.

(iii) **BILL-The Industrial Relations Code, 2019.**

SHRI SANTOSH KUMAR GANGWAR to move for leave to introduce a Bill to consolidate and amend the laws relating to Trade Unions, conditions of employment in industrial establishment or undertaking, investigation and settlement of industrial disputes and for matters connected therewith or incidental thereto.
