- (ii) Suitable legislation to accord right of voting to the prisoners who are not yet been convicted SHRI SUSHIL KUMAR SINGH to move: "This House urges upon the Government to bring forward a suitable legislation to enable the undertrial prisoners, who are lodged in jails but have not yet been convicted, to exercise their right to vote during the elections to the House of the People and the Legislative Assemblies of the States.".
