ARREST AND RELEASE OF SHRI RAJBAHADUR SINGH

The following communication dated 06 December, 2019 from Superintendent of Police, Sagar district, Madhya Pradesh was received on 09 December, 2019:-

“This is to inform that Shri Rajbahadur Singh, Member of Lok Sabha, alongwith others, was arrested on 06 December, 2019 u/s 151 of Cr.PC apprehending that a cognizable offence can be committed by them in connection with a demonstration staged by them against non-supply of urea and manure seeds at Rajakhedi Bajaria PS, Makroniya. Later he was released on bond by City Magistrate.”
