The following subjects have been selected for examination by the Committee on the Welfare of Scheduled Castes and Scheduled Tribes during the year 2019-20

- Examination of Annual Reports of National Commission for Scheduled Tribes
 presented under Article 338A(5)(d) of the Constitution of India and to report as to the
 measures that should be taken by the union Government in respect to matters within
 the purview of the Union Government.
- Status of constitution of All India Judicial Service in terms of the Constitutional provisions.
- Reservation for and employment of Scheduled Castes and Scheduled Tribes in Delhi Police.
- Role of the Ministry of personnel, Public Grievances and Pensions (Department of Personnel & Training) in formulation, implementation and monitoring of reservation policy.
- Reservation for and employment of Scheduled Castes and Scheduled Tribes in New Delhi Municipal Council (NDMC).
- 6. Reservation for and employment of Scheduled Castes and Scheduled Tribes in Delhi Metro Rail Corporation (DMRC).
- 7. Advancement of Scheduled Castes and Scheduled Tribes under 'Corporate Social Responsibility' funding and schemes.
- Reservation for and employment of Scheduled Castes and Scheduled Tribes in the Indian Railways.
- 9. Study of atrocity cases against Scheduled Castes and Scheduled Tribes with respect to implementation of the Prevention of Atrocities Act, 1989.
- Reservation for Scheduled Castes and Scheduled Tribes in Public Sector Banks/Financial Institutions/Reserve Bank of India and credit facilities being provided to them by the Banks.
