**4. SHRI RAVI SHANKAR PRASAD** to move for leave to introduce a Bill further to amend the Supreme Court (Number of Judges) Act, 1956.

(ii) Consideration of Rajya Sabha Amendments

**6. DR. HARSH VARDHAN** to move that the following amendments made by Rajya Sabha in the Bill to provide for a medical education system that improves access to quality and affordable medical education, ensures availability of adequate and high quality medical professionals in all parts of the country; that promotes equitable and universal healthcare that encourages community health perspective and makes services of medical professionals accessible to all the citizens; that promotes national health goals; that encourages medical professionals to adopt latest medical research in their work and to contribute to research; that has an objective periodic and transparent assessment of medical institutions and facilitates maintenance of a medical register for India and enforces high ethical standards in all aspects of medical services; that is flexible to adapt to changing needs and has an effective grievance redressal mechanism and for matters connected therewith or incidental thereto, be taken into consideration:–

**CLAUSE 4**

1. That at page 3, line 27, ***for*** the word "fourteen", the word "twenty-two" be ***substituted.***
2. That at page 4, line 16, ***for*** the word "six", the word "ten" be ***substituted.***
3. That at page 4, line 20, ***for*** the word "five", the word "nine" be ***substituted.***

**CLAUSE 37**

4. That at page 18, line 24, ***after*** the words "qualification to be equivalent", the words "for the purposes of teaching also." be ***inserted.***

**ALSO** to move that the amendments made by Rajya Sabha be agreed to.

\*Motor Vehicles  
(Amendment)  
Bill, 2019.

**7. SHRI NITIN GADKARI** to move that the following amendments made by Rajya Sabha in the Bill further to amend the Motor Vehicles Act, 1988, be taken into consideration:—

**CLAUSE 30**

1. That at page 11, line 25, ***for*** the word "consultation", the word "concurrence" be ***substituted***.

**CLAUSE 34**

2. That at page 14, line 2, ***for*** the word "consult", the words "seek concurrence of" be ***substituted***.

**CLAUSE 77**

3. That at page 37, line 24, ***for*** the word, bracket and figure "sub-section (4)", the word, bracket and figure "sub-section (1)" be ***substituted***.

**ALSO** to move that the amendments made by Rajya Sabha be agreed to.
