\*National Medical Commission Bill, 2019. **6. DR. HARSH VARDHAN** to move that the following amendments made by Rajya Sabha in the Bill to provide for a medical education system that improves access to quality and affordable medical education, ensures availability of adequate and high quality medical professionals in all parts of the country; that promotes equitable and universal healthcare that encourages community health perspective and makes services of medical professionals accessible to all the citizens; that promotes national health goals; that encourages medical professionals to adopt latest medical research in their work and to contribute to research; that has an objective periodic and transparent assessment of medical institutions and facilitates maintenance of a medical register for India and enforces high ethical standards in all aspects of medical services; that is flexible to adapt to changing needs and has an effective grievance redressal mechanism and for matters connected therewith or incidental thereto, be taken into consideration:-

- 1. That at page 3, line 27, <u>for</u> the word "fourteen", the word "twenty-two" be <u>substituted.</u>
- 2. That at page 4, line 16, <u>for</u> the word "six", the word "ten" be <u>substituted.</u>
- 3. That at page 4, line 20, <u>for</u> the word "five", the word "nine" be <u>substituted.</u>

## **CLAUSE 37**

4. That at page 18, line 24, <u>after</u> the words "qualification to be equivalent", the words "for the purposes of teaching also." be <u>inserted.</u>

**ALSO** to move that the amendments made by Rajya Sabha be agreed to.
