M.P's & Ex-M.P's Car Park Label

Hon'ble M.P's and Ex-M.P's are informed that new M.P/Ex-MP Car Park Labels **marked 2020** will be issued to M.P's & Ex-M.P's of Lok Sabha from **10th February, 2020** onwards. **Till 31st March, 2020 the existing car "P" label (2019) will continue in work and will become invalid and ineffective w.e.f. 1st April 2020.**

Hon'ble M.P's & Ex-M.P's desirous to have Car Park Label are requested to collect the same after filling the necessary form, which is available in Centralised Pass Issue Cell, Parliament House. M.P's/Ex-M.P's. are also requested not to apply for M.P/Ex-M.P Car Park Label for Taxis and Commercial Vehicles such as DLY, DLZ and DLT etc.

Hon'ble M.P's/Ex-M.P's are informed that as per past practice, only one MP/Ex-MP Car Park Label will be issued to a Hon'ble Member. **"The old parking labels issued for the year 2019 has to be returned therewith"**.

Hon'ble M.P's/Ex-MP's are also informed that in order to avoid any confusion at the Iron Gates and inconvenience to them, it is requested that w.e.f. **1st April 2020** only '**P**' label marked **2020**, be displayed on the windscreen and **old 'P' label** (s) (if issued by CPIC) be removed from the windscreen and surrendered at CPIC.
