RESOLUTIONS

16. FURTHER DISCUSSION on the following resolution moved by Shri Ritesh Pandey on the 20th March, 2020 :-

"Keeping in view that the Anganwadi Workers and *Welfare* Anganwadi Helpers provide many essential *measures for* health and welfare services to women, children Anganwadi and adolescents, this House urges upon the Workers and Government to take following immediate steps to Anganwadi uplift their working conditions -

Helpers.

- (1) regularisation of employment of Anganwadi Workers and Anganwadi Helpers;
- changing the nomenclature (2) of compensation category of Anganwadi Workers and Anganwadi Helpers from 'Honorarium' to 'Salary';
- (3) payment of adequate amount of compensation to Anganwadi Workers and which Anganwadi Helpers, would reflect importance of their services to the society;
- improving working conditions Anganwadi Workers and Anganwadi Helpers and upgrading every Anganwadi Centre with all basic facilities including availability of safe drinking water, clean toilets and proper ventilation; and
- (5) payment of all dues including pending rent for Anganwadi Centres which are being run on rented accommodation in the country.".

17. SHRI RAVI KISHAN to move :-

"This House urges upon the Government to bring forward a suitable legislation to include 'Bhojpuri' language in the Eighth Schedule to the Constitution.".

18. DR. SHASHI THAROOR to move :-

"Keeping in view the welfare of the fishing community *Central* in the country and the devastating impact of Government to Covid-19 pandemic and recurrent floods on their take steps to this House urges livelihood, upon Government to take the following steps to *plight of fishing* mitigate their plight:-

- (i) creation of a separate and standalone Ministry of Fisheries with earmarked resources, given the specialized nature of the fisheries sector and its contrast to land farming;
- (ii) revamp the existing National Fisheries Development Board to reflect better a representation of States involved in fishing activities and setting up of a regional centre at Thiruvananthapuram;
- (iii) establishment of a National Fisheries Council with zonal, State and local offices to channelize disbursal of benefits and ensure grassroots level implementation of schemes;
- (iv) setting up of a Forum of Members of Parliament representing coastal regions to highlight and voice the concerns of the fisherfolk community across the country; and
- (v) devisina innovative an and comprehensive set of solutions to the existing issues with the aid and advice of subject matter experts and inputs from stakeholders, especially representatives of the community.".

19. SHRI SADASHIV LOKHANDE to move :-

"Keeping in view that the Below Poverty Line (BPL) ration card holders, most of whom are poor, labourers and destitutes, and their divided families are being deprived of facility of subsidised food grains of the Government, this House urges upon the Government to take appropriate steps to ensure provision of highly subsidised food grains facilities to all BPL ration card holders and their divided families under the 'One Nation One Ration Card' Scheme, in urban and rural areas of the country."
